
#### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (17.75msec) never exceeds a series of 4 long (1.375msec) and 10 short (500 $\mu$ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 4x1.375msec+10x500 $\mu$ sec per 17.75msec=59.1% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.






Inner Circuit Top View



Inner Circuit Bottom View




