
Each function key sends a different series of characters, but each packet period (34.3msec) never exceeds a series of 6 long (1.575msec) and 10 short (525 μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered 6x1.575msec+10x525 μ sec per 34.3msec=42.8% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

Figure B [Long Pulse]





Figure C [Short Pulse]
