



The sample was placed 0.8m above the ground plane on the OATS \*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.






#### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (35.06msec) never exceeds a series of 6 long (1.625msec) and 10 short ( $500\mu$ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered  $6x1.625\mu$ sec+ $10x500\mu$ sec per 35.06msec=42% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

Duty Cycle Correction = 20Log(0.42) =-7.5dB



Front View of the product





Inner Circuit Top View
