




Each function key sends a different series of characters, but each packet period (70.75msec) never exceeds a series of 1 long (21.5msec) and 31 short (1.25msec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 21.5+31x1.25msec per 70.75msec=85.1% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Figure B [Long Pulse]





Figure C [Short Pulse]










Rear View of the product
