




Each function key sends a different series of characters, but each packet period (25.75msec) never exceeds a series of 3 long (4.875 and 1.375) and 15 short (500μsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 4.875+2x1.375+15x500μsec per 25.75msec=58.7% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Figure B [Long Pulse 1]





Figure B [Long Pulse 2]






Rear View of the product
