



Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (33.0msec) never exceeds a series of 8 long (1msec) and 18 short (450 μ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 8x1msec+18x450 μ sec per 33.0msec=48.7% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Figure B [Long Pulse]





Figure C [Short Pulse]


Front View of the product




Rear View of the product
