




#### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (20.375msec) never exceeds a series of 4 long (1.625msec) and 10 short (500 $\mu$ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worst case transmit duty cycle would be considered 4x1.625msec+10x500 $\mu$ sec per 20.375msec=46.4% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.






