

Before you start


- 1.Make sure your computer, namely PC, notebook or PDA has Bluetooth utility and hardware device well-installed. (This is can be checked by the existence of a Bluetooth icon on the bottom right corner of your screen)
- 2.If you are using Windows 98, have Windows 98
 CD on hand as the installation program may require the original CD while installing.

Getting Started

- Connect a telephone line to the Line port of the Bluetooth 56K Modem.
- 2. Power on the Bluetooth 56K Modem.
- Open "My Bluetooth Places" which should be present on your desk.
- Click Entire Bluetooth Neighborhood to search the Bluetooth 56K Modem..



- The Bluetooth 56K Modem shall be found if this computer has used the Bluetooth service.




