Re: Attestation letter for uniform spreading , FCC ID: LYHELN1V1


We, Siemens AG, I IA SC CI, Gleiwitzer Str. 555, 90475 Nürnberg, Germany, declare that our access points with FCC ID: LYHELN1V1, require professional installation, as explained in the supplied user manual.

For the installation process, the professional installer will be provided with an administrator password. Only with this password it would be possible to change the device configuration and only the professional installer is authorized to perform this operation. By default, the WLAN interface is disabled.


When configured to perform automatic channel selection the Access Point will ensure uniform spreading by implementing a routine at startup and restart where the initial channel of operation is chosen randomly among the channels with least interference. This will ensure that the Access Point will utilize all available channels in the 5 GHz band.

Alternatively, a professional installer can manually set an initial channel of operation and thus has to ensure uniform channel utilization across all Access Points in a large deployment.


