The *Transmitter A2C32337200* operated in continuous transmitting mode after connecting the DC power line. (Prepared sample only for radiated emission tests, (Diagnose mode))

The Transmitter A2C32337200 operated in normal mode for transmission time measurements.

All buttons (Unlock button, Lock button, Tailgate button and Panic button) send the same output power and use the same message format. The only difference is the sequence of individual pulses.

The receiver reading is 32.7 dB μ V. The antenna factor for the measured frequency is +2.5 dB (1/m) and the cable factor for the measured frequency is 0.71 dB, giving a field strength of 35.91dB μ V/m. The 35.91dB μ V/m value can be mathematically converted to its corresponding level in μ V/m.

8.7 Bandwidth (20 dB)

8.7.1 Regulation

(c) The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.
