# **User's Manual**

This device complies with Part 15 of the FCC Rules. Operation is subject to the following two conditions: (1) this device may not cause harmful interference, and (2) this device must accept any interference received, including interference that may cause undesired operation. ## 3.1. Installation Overview

XG-730 wireless module is design for Access Point, Router, ATU-R, Printer Server series, IP Camera series and Internet Video Server only.

### 3.2. Safety Recommendations

## 3.4. Installing a XG-730

 $\lambda$  Remove the XG-730 module from its protective packaging.

 $\lambda$  Avoiding Electrostatic Discharge

Before you install the XG-730 module, ground yourself by touching a piece of metal to avoid electrostatic discharge (ESD). You should also take the following precautions to prevent damage to the XG-730 module:

 $\lambda\,$  Keep the XG-730 module in its antistatic-shielded bag until you are ready to install it.

 $\lambda$  Handle the XG-730 module by its edges.

 $\lambda\,$  Ensure the connector is connected to above Model's board tightly.
