



7.1 Block Diagram of Test Setup

Above 18 GHz shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade form 3m to 1m.

Distance extrapolation factor = 20 log (specific distanc [3m] / test distance [1.5m]) (dB); Limit line = specific limits (dBuV) + distance extrapolation factor [6 dB].

- (a) Fundamental components of modulation of licence-exempt radio apparatus shall not fall within the restricted bands of Table 6 except for apparatus complying under RSS-287;
- (b) Unwanted emissions that fall into restricted bands of Table 6 shall comply with the limits specified in RSS-Gen; and

case the emission fall within the restricted band specified on 15.205(a), then the 15.209(a) limit in the table below has to be followed.

According to RSS-GEN§8.9: Except when the requirements applicable to a given device state otherwise, emissions from licence-exempt transmitters shall comply with the field strength limits shown in the Table below. Additionally, the level of any transmitter emission shall not exceed the level of the transmitter's fundamental emission.

According to RSS-GEN§7.1.2: Radiated emission measurements shall be performed with the receiver antenna connected to the receiver antenna terminals. The search for spurious emissions shall be from the lowest frequency internally generated or used in the receiver (e.g. local oscillator, intermediate or carrier frequency), or 30 MHz, whichever is higher, to at least 5x the highest tunable or local oscillator frequency, whichever is higher, without exceeding 40 GHz.

7.4 Test Procedures

1) Sequence of testing 9 kHz to 30 MHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 0.8 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions.
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna height is 0.8 meter.
- --- At each turntable position the analyzer sweeps with peak detection to find the maximum of all emissions

Final measurement:

- --- Identified emissions during the premeasurement the software maximizes by rotating the turntable position (0° to 360°) and by rotating the elevation axes (0° to 360°).
- --- The final measurement will be done in the position (turntable and elevation) causing the highest emissions with QPK detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

2) Sequence of testing 30 MHz to 1 GHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a table with 0.8 m height is used, which is placed on the ground plane.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height changes from 1 to 3 meter.
- --- At each turntable position, antenna polarization and height the analyzer sweeps three times in peak to find the maximum of all emissions.

Final measurement:

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position (± 45°) and antenna movement between 1 and 4 meter.
- --- The final measurement will be done with QP detector with an EMI receiver.
- --- The final levels, frequency, measuring time, bandwidth, antenna height, antenna polarization, turntable angle, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

3) Sequence of testing 1 GHz to 18 GHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 3 meter.
- --- The EUT was set into operation.

Premeasurement:

- --- The turntable rotates from 0° to 315° using 45° steps.
- --- The antenna is polarized vertical and horizontal.
- --- The antenna height scan range is 1 meter to 2.5 meter.
- --- At each turntable position and antenna polarization the analyzer sweeps with peak detection to find the maximum of all emissions.

Final measurement:

- --- The final measurement will be performed with minimum the six highest peaks.
- --- According to the maximum antenna and turntable positions of premeasurement the software maximize the peaks by changing turntable position (± 45°) and antenna movement between 1 and 4 meter. This procedure is repeated for both antenna polarizations.
- --- The final measurement will be done in the position (turntable, EUT-table and antenna polarization) causing the highest emissions with Peak and Average detector.
- --- The final levels, frequency, measuring time, bandwidth, turntable position, EUT-table position, antenna polarization, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement with marked maximum final measurements and the limit will be stored.

4) Sequence of testing above 18 GHz

Setup:

- --- The equipment was set up to simulate a typical usage like described in the user manual or described by manufacturer.
- --- If the EUT is a tabletop system, a rotatable table with 1.5 m height is used.
- --- If the EUT is a floor standing device, it is placed on the ground plane with insulation between both.
- --- Auxiliary equipment and cables were positioned to simulate normal operation conditions
- --- The AC power port of the EUT (if available) is connected to a power outlet below the turntable.
- --- The measurement distance is 1 meter.
- --- The EUT was set into operation.

Premeasurement:

--- The antenna is moved spherical over the EUT in different polarizations of the antenna.

Final measurement:

- --- The final measurement will be performed at the position and antenna orientation for all detected emissions that were found during the premeasurements with Peak and Average detector.
- --- The final levels, frequency, measuring time, bandwidth, correction factor, margin to the limit and limit will be recorded. Also a plot with the graph of the premeasurement and the limit will be stored.

7.5 EUT Operation during Test

The EUT was programmed to be in continuously transmitting mode.





8. POWER LINE CONDUCTED EMISSIONS


8.1 Standard Applicable

According to §15.207 (a) and RSS-GEN: For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed 250 microvolts (The limit decreases linearly with the logarithm of the frequency in the range 0.15 MHz to 0.50 MHz). The limits at specific frequency range are listed as follows:





AC Conducted Emission of power adapter @ AC 120V/60Hz @ GFSK (worst case)








9. BAND-EDGE MEASUREMENTS FOR RADIATED EMISSIONS

9.1 Standard Applicable

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB. Attenuation below the general limits specified in §15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in §15.209(a) (see §15.205(c)).

According to section 5.5 of RSS-247: In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated device is operating, the RF power that is produced shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided that the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of root-mean-square averaging over a time interval, as permitted under Section 5.4(4), the attenuation required shall be 30 dB instead of 20 dB. Attenuation below the general field strength limits specified in RSS-Gen is not required.

9.4. Test Procedures

According to KDB 412172 section 1.1 Field Strength Approach (linear terms):

eirp = $p_t \times g_t = (E \times d)^2/30$

Where:

 p_t = transmitter output power in watts,

 g_t = numeric gain of the transmitting antenna (unitless),

E = electric field strength in V/m,

d = measurement distance in meters (m).

 $erp = eirp/1.64 = (E \times d)^2/(30 \times 1.64)$

Where all terms are as previously defined.

- 1. Check the calibration of the measuring instrument using either an internal calibrator or a known signal from an external generator.
- 2. Remove the antenna from the EUT and then connect to a low loss RF cable from the antenna port to a EMI test receiver, then turn on the EUT and make it operate in transmitting mode. Then set it to Low Channel and High Channel within its operating range, and make sure the instrument is operated in its linear range.

- 3. Set both RBW and VBW of spectrum analyzer to 100 kHz with a convenient frequency span including 100kHz bandwidth from band edge, for Radiated emissions restricted band RBW=1MHz, VBW=3MHz for peak detector and RBW=1MHz, VBW=1/B for Peak detector.
- 4. Measure the highest amplitude appearing on spectral display and set it as a reference level. Plot the graph with marking the highest point and edge frequency.
- 5. Repeat above procedures until all measured frequencies were complete.
- 6. Measure the conducted output power (in dBm) using the detector specified by the appropriate regulatory agency for guidance regarding measurement procedures for determining quasi-peak, peak, and average conducted output power, respectively).
- 7. Add the maximum transmit antenna gain (in dBi) to the measured output power level to determine the EIRP level (see 12.2.5 for guidance on determining the applicable antenna gain)
- 8. Add the appropriate maximum ground reflection factor to the EIRP level (6 dB for frequencies ≤ 30 MHz, 4.7 dB for frequencies between 30 MHz and 1000 MHz, inclusive and 0 dB for frequencies > 1000 MHz).
- 9. For devices with multiple antenna-ports, measure the power of each individual chain and sum the EIRP of all chains in linear terms (e.g., Watts, mW).
- 10. Compare the resultant electric field strength level to the applicable regulatory limit.
- 11. Perform radiated spurious emission test duress until all measured frequencies were complete.



However, for devices that operate in multiple frequency bands while using the same transmit antenna, the highest gain of the antenna within the operating band nearest in frequency to the restricted band emission being measured may be used in lieu of the overall highest gain when the emission is at a frequency that is within 20 percent of the nearest band edge frequency, but in no case shall a value less than 2 dBi be used.

10. ANTENNA REQUIREMENT

10.1 Standard Applicable

According to antenna requirement of §15.203.

An intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this Section. The manufacturer may design the unit so that a broken antenna can be re-placed by the user, but the use of a standard antenna jack or electrical connector is prohibited. This requirement does not apply to carrier current devices or to devices operated under the provisions of Sections 15.211, 15.213, 15.217, 15.219, or 15.221. Further, this requirement does not apply to intentional radiators that must be professionally installed, such as perimeter protection systems and some field disturbance sensors, or to other intentional radiators which, in accordance with Section 15.31(d), must be measured at the installation site. However, the installer shall be responsible for ensuring that the proper antenna is employed so that the limits in this Part are not exceeded.

And according to §15.247(4)(1), system operating in the 2400-2483.5MHz bands that are used exclusively for fixed, point-to-point operations may employ transmitting antennas with directional gain greater than 6dBi provided the maximum peak output power of the intentional radiator is reduced by 1 dB for every 3 dB that the directional gain of the antenna exceeds 6dBi.

According to RSS-Gen,

The applicant for equipment certification, as per RSP-100, must provide a list of all antenna types that may be used with the licence-exempt transmitter, indicating the maximum permissible antenna gain (in dBi) and the required impedance for each antenna.

Licence-exempt transmitters that have received equipment certification may operate with different types of antennas. However, it is not permissible to exceed the maximum equivalent isotropically radiated power (e.i.r.p.) limits specified in the applicable standard (RSS) for the licence-exempt apparatus.

Testing shall be performed using the highest gain antenna of each combination of licence-exempt transmitter and antenna type, with the transmitter output power set at the maximum level.9 When a measurement at the antenna connector is used to determine RF output power, the effective gain of the device's antenna shall be stated, based on a measurement or on data from the antenna manufacturer.

10.2 Antenna Connected Construction

10.2.1. Standard Applicable

According to § 15.203 & RSS-Gen, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

10.2.2. Antenna Connector Construction

The directional gains of antenna used for transmitting is 2.0dBi, and the antenna is an integral antenna connect to PCB board and no consideration of replacement. Please see EUT photo for details. The WLAN and BT share same antenna:

10.2.3. Results: Compliance.

Measurement

The antenna gain of the complete system is calculated by the difference of radiated power in EIRP and the conducted power of the module.

Conducted power refers ANSI C63.10:2013 Output power test procedure for FHSS devices. Radiated power refers to ANSI C63.10:2013 Radiated emissions tests.
