Your High Velocity Air Circulator has been designed and manufactured using the latest in technology. With normal care and use it should provide many years of satisfactory performance. As with all small appliances, it is recommended that you note the following:

• ALWAYS unplug unit for cleaning.

• ALWAYS unplug unit when not in use.

• ALWAYS unplug when moving blower from one location to the next.

• DO NOT use an extension cord. Plug the unit directly into an electrical cutlet of the correct valuage.

is turn the fain on press the Fower/Speed button on the remote control or on the back of the

our fan has 3 speed settings HIGH (III), MED (III) and LOW (II). The very first time you turn on our fan from the back, it will start on the High setting. The buttons on the remote and the lower/Speed button located on the back of the fan will turn the fan on, off and cycle through ne speeds. As long as the fan remains plugged into a power source, the control board will emember the last speed setting set before it was turned off and will automatically start from that ame speed when turned back on. If unplugged, the fan will start on the High speed setting then turned on again.

is turn the fan off, press and hold the Power/Speed button, which is located on the rear of the nit. By pressing and holding this button for 3 seconds the fun will shut off or simply press the ff (O) button on the remote.

on air circulators can be used alone or in conjunction with an air conditioning unit to ulate the cooled air or to force it into other rooms. During summer days, the portable on Air Circulator can be used as a hassock fan to pick up cool air and circulate it through enline room.

normal for the motor to feel warm to the touch during operation. The motor is thermally ected and will automatically shut of should it overheat. If this happens immediately onnect the fan from the power outlet
