

Uncertainty resulting from the boundary effect is less than 2% for the distance between the tip of the probe and the tissue boundary, when less than 2.44mm.





# Isotropy Error 835 MHz (Air)





To minimize the uncertainty calculation all tissue sensitivity values were calculated using a load impedance of 5 M $\Omega$ .

#### **Boundary Effect:**

For a distance of 2.5mm the evaluated uncertainty (increase in the probe sensitivity) is less than 2%.
