2. METHODOLOGY

The measurement procedure described in the American National Standard of Procedures for Compliance Testing of

Unlicensed Wireless Devices (ANSI C63.10-2013) is used in the measurement of the test device.

EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement

and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.225

under the FCC Rules Part 15 Subpart C and RSS-210 Issue 10, RSS-Gen Issue 5.

GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 6.2

of ANSI C63.10. (Version :2013) Conducted emissions from the EUT measured in the frequency range between 0.15

MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane below 1GHz. Above 1GHz with 1.5m using

absorbers between the EUT and receive antenna. The turntable shall rotate 360 degrees to determine the position of

maximum emission level. EUT is set 3.75 m away from the receiving antenna, which varied from 1 m to 4 m to find out

the highest emission. Also, each emission was to be maximized by changing the polarization of receiving antenna both

horizontal and vertical. In order to find out the max. emission, the relative positions of this hand-held transmitter

(EUT) was rotated through three orthogonal axes according to the requirements in Section 8 of ANSI C63.10. (Version:

2013)

DESCRIPTION OF TEST MODES

The EUT has been tested under operating condition. Test program used to control the EUT for staying in continuous

transmitting mode is programmed.

3. INSTRUMENT CALIBRATION

The measuring equipment, which was utilized in performing the tests documented herein, has

been calibrated in accordance with the manufacturer's recommendations for utilizing calibration

equipment's, which is traceable to recognized national standards.

Especially, all antenna for measurement is calibrated in accordance with the requirements of C63.5 (Version: 2017).

4. FACILITIES AND ACCREDITATIONS

FACILITIES

The SAC (Semi-Anechoic Chamber) and conducted measurement facility used to collect the radiated data are located

at 1726 Ringwood Avenue, San Jose, California 95131, USA.

The site is constructed in conformance with the requirements of ANSI C63.4. (Version :2014) and CISPR Publication 22.

EQUIPMENT

Radiated emissions are measured with one or more of the following types of Linearly polarized antennas: tuned dipole,

bi-conical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with pre-selectors and quasi-peak

detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test

Receivers. Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making

measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring

Apparatus and Measurement Methods."

5. ANTENNA REQUIREMENTS

According to FCC 47 CFR §15.203:

"An intentional radiator antenna shall be designed to ensure that no antenna other than that furnished by the

responsible party can be used with the device. The use of a permanently attached antenna or of an antenna that uses

a unique coupling to the intentional radiator shall be considered sufficient to comply with the provisions of this

section."

6. MEASUREMENT UNCERTAINTY

The measurement uncertainties shown below were calculated in accordance with the requirements of ANSI C63.10-2013.

The measurement data shown herein meets or exceeds the U_{CISPR} measurement uncertainty values specified in CISPR 16-4-2 and, thus, can be compared directly to specified limits to determine compliance.


7.1. 20 dB Bandwidth

Limit

Test Requirements §15.215 (c)

The bandwidth at 20 dB down from the highest in-band spectral density is measured with a spectrum analyzer connected to the receive antenna while the EUT is operating in transmission mode at the appropriate frequencies.

Test Procedure

The transmitter output is connected to the Spectrum Analyzer.

The Spectrum Analyzer is set to

- 1) RBW = 1 kHz
- 2) VBW = 3 x RBW
- 3) Detector = Peak
- 4) Trace mode = max hold
- 5) Sweep = auto couple
- 6) Allow the trace to stabilize
- 7) We tested 20 dB bandwidth using the automatic bandwidth measurement capability of a spectrum analyzer, setting X dB as 20 dB.






7.3. Frequency Stability

The frequency tolerance of the carrier signal shall be maintained within ±0.01% of the operating frequency.

Test Procedure.

For battery operated equipment, the equipment tests shall be performed using a new battery.

- Turn the EUT OFF and place it inside the environmental temperature chamber.
 For devices that have oscillator heaters, energize only the heater circuit.
- 2) Set the temperature control on the chamber to the highest specified in the regulatory requirements for the type of device and allow the oscillator heater and the chamber temperature to stabilize.
- 3) While maintaining a constant temperature inside the environmental chamber, turn the EUT ON and record the operating frequency at startup, and at 2 minutes, 5 minutes, and 10 minutes after the EUT is energized. Four measurements in total are made.

1) Temperature:

The temperature is varied from -20°C to + 50°C using an environmental chamber.

2) Primary Supply Voltage:

The primary supply voltage is varied from 85% to 115% of the nominal value for non hand-carried battery and AC powered equipment.

For hand-carried, battery-powered equipment, primary supply voltage is reduced to the battety operating end point which shall be specified by the manufacturer.





Test Procedure of Radiated spurious emissions (Below 30 MHz)

- 1. The EUT was placed on a non-conductive table located on semi-anechoic chamber.
- 2. The loop antenna was placed at a location 3m from the EUT
- 3. The EUT is placed on a turntable, which is 0.8m above ground plane.
- 4. We have done x, y, z planes in EUT and horizontal and vertical polarization in detecting antenna.
- 5. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 6. Distance Correction Factor (0.009 MHz 0.490 MHz) = 40*log(3 m/300 m) = -80 dB

Measurement Distance: 3 m

7. Distance Correction Factor (0.490 MHz - 30 MHz) = 40*log(3 m/30 m) = -40 dB

7.5. AC Power line Conducted Emissions

<u>Limit</u>

For an intentional radiator that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies, within the band 150 kHz to 30 MHz, shall not exceed the limits in the following table, as measured using a 50 μ H/50 ohms line impedance stabilization network (LISN).

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

Test Procedure

- 1. The EUT is placed on a wooden table 80 cm above the reference ground plane.
- 2. The EUT is connected via LISN to a test power supply.
- 3. The measurement results are obtained as described below:
- 4. Detectors: Quasi Peak and Average Detector.









Operation within the band 13.110 MHz – 14.010 MHz Horizontal plot








Radiated Spurious Emissions plot Below 30 MHz Horizontal plot



Radiated Spurious Emissions plot Below 30 MHz Vertical plot




