





4.6.1 LIMITS OF BAND EDGES MEASUREMENT

Below –20dB of the highest emission level of operating band (in 100KHz Resolution Bandwidth).

4.6.2 TEST INSTRUMENTS

NOTE:

- 1.The measurement uncertainty is less than +/- 2.6dB, which is calculated as per the NAMAS document NIS81.
- 2. The calibration interval of the above test instruments is 12 months and the calibrations are traceable to NML/ROC and NIST/USA.

4.6.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.


4.6.5 TEST RESULTS - DSSS

The spectrum plots are attached on the following 2 pages. D1 line indicates the highest level, D2 line indicates the 20dB offset below D1. It shows compliance with the requirement in part 15.247(C).


NOTE (1): The band edge emission plot on the following first page shows 53.84dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.7 is 101.1dBuV/m, so the maximum field strength in restrict band is 101.1-53.84=47.26dBuV/m which is under 54 dBuV/m limit.

NOTE (2): The band edge emission plot on the following second page shows 54.77dB delta between carrier maximum power and local maximum emission in restrict band (2.4852GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.7 is 100.7dBuV/m, so the maximum field strength in restrict band is 100.7-54.77=45.93dBuV/m which is under 54 dBuV/m limit.












4.6.6 TEST RESULTS-OFDM

The spectrum plots are attached on the following 2 pages. D1 line indicates the highest level, D2 line indicates the 20dB offset below D1. It shows compliance with the requirement in part 15.247(C).


NOTE (1): The band edge emission plot on the following first page shows 45.43dB delta between carrier maximum power and local maximum emission in restrict band (2.3896GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.8 is 91.9dBuV/m, so the maximum field strength in restrict band is 91.9-45.43=46.47dBuV/m which is under 54 dBuV/m limit.

NOTE (2): The band edge emission plot on the following second page shows 43.77dB delta between carrier maximum power and local maximum emission in restrict band (2.4836GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.8 is 91.0dBuV/m, so the maximum field strength in restrict band is 91.0-43.77=47.23dBuV/m which is under 54 dBuV/m limit.

4.7 ANTENNA REQUIREMENT

4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

4.7.2 ANTENNA CONNECTED CONSTRUCTION

The antenna type used in this product is Dipole Antenna with HRS connector. And the maximum Gain of this antenna is only 4dBi.




