

4.1.3 TEST PROCEDURES


- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission level under (Limit 20dB) was not recorded.





4.2.4 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 3 meter semi-anechoic camber. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. 





Peak Power Output: CH1










1.The measurement uncertainty is less than +/- 2.6dB, which is calculated as per the NAMAS document NIS81. This uncertainty represents an expanded uncertainty expressed at approximately the 95% confidence level using a coverage factor of k=2.

2. The calibration interval of the above test instruments is 12 months and the calibrations are traceable to NML/ROC and NIST/USA.

4.7.2 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 1MHz with suitable frequency span including 100 MHz bandwidth from band edge. The band edges was measured and recorded.

4.7.3 EUT OPERATING CONDITION

The software provided by client to enable the EUT under transmission condition continuously at specific channel frequencies individually.



4.7.4 TEST RESULTS

For signals in the restricted bands above and below the 5.15 to 5.35GHz allocated band a measurement was made of the amplitude of the spurious emissions with respect to the intentional signals. The relative amplitude, in dBc, was applied to the average and peak filed strength of the intentional signal made on the OATS to calculate the field strength of the unintentional signals.

The spectrum plots (Peak RBW=VBW=1MHz; Average RBW=1MHz, VBW=10Hz) are attached on the following pages.

NOTE (Peak):

The band edge emission plot on the following first page shows 53.01dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 1 is 106.5dBuV/m (Peak), so the maximum field strength in restrict band is 106.5-53.01=53.49dBuV/m which is under 74dBuV/m limit.


The band edge emission plot on the following first page shows 39.31dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 8 is 110.9dBuV/m (Peak), so the maximum field strength in restrict band is 110.9-39.31=71.59dBuV/m which is under 74dBuV/m limit.



The emission of carrier strength list in the test result of channel 1 is 98.2dBuV/m (Average), so the maximum field strength in restrict band is 98.2-55.02=43.18dBuV/m which is under 54dBuV/m limit.

The band edge emission plot on the following second page shows 48.77dBc between carrier maximum power and local maximum emission in restrict band. The emission of carrier strength list in the test result of channel 8 is 101.9dBuV/m (Average), so the maximum field strength in restrict band is 101.9-48.77=53.13dBuV/m which is under 54dBuV/m limit.
















4.8 ANTENNA REQUIREMENT


The antenna used in this product is PCB antenna with HRS connector. The maximum Gain of the antenna is 2.05dBi.
