 $Pd = (Pout*G) / (4*pi*r^2)$

where

Pd = power density in mW/cm2

Pout = output power to antenna in mW

G = gain of antenna in linear scale

pi = 3.1416

r = distance between observation point and center of the radiator in cm

CONCLUSION:

Both of the WLAN and Bluetooth can transmit simultaneously, the formula of calculated the MPE is:

 $CPD_1/LPD_1 + CPD_2/LPD_2 + \dots etc. < 1$

CPD = Calculation power density

LPD = Limit of power density

Therefore, the worst-case situation is 0.05698 / 1 + 0.00071 / 1 = 0.0681, which is less than "1". This confirmed that the device comply with FCC 1.1310 MPE limit.
