3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 2.1046, 2.1047, 2.1049, 2.1051, 2.1053, 2.1055, 2.1057, 15.207, 15.209 and 15.247.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The EUT was operated in the engineering mode to fix the TX frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4 Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

3.5 DESCRIPTION OF TEST MODES

The EUT (model: J27H002) had been tested under operating condition.

Test program used to control the EUT for staying in continuous transmitting mode was programmed.

Software used to control the EUT for staying in continuous transmitting mode was programmed. The worst case data rate is determined as the data rate with highest output power.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz and power line conducted emissions below 30MHz, which worst case was in normal link mode only.

Channel Low (2402MHz), Mid (2441MHz) and High (2480MHz) with 3Mbps data rate were chosen for full testing.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."






7.2 BAND EDGES MEASUREMENT

LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. 



Band Edges (CH Low)


Detector mode: Peak Polarity: Vertical




Detector mode: Average Polarity: Vertical



Detector mode: Peak Polarity: Horizontal




Detector mode: Average Polarity: Horizontal








Detector mode: Average Polarity: Vertical



PPSD (CH Low)




PPSD (CH Mid)










7.6 TIME OF OCCUPANCY (DWELL TIME)

LIMIT

According to \$15.247(a)(1)(iii), Frequency hopping systems operating in the 2400MHz-2483.5 MHz bands. The average time of occupancy on any channels shall not greater than 0.4 s within a period 0.4 s multiplied by the number of hopping channels employed.

TEST PROCEDURE

The transmitter output is connected to a spectrum analyzer. The span is set to 0 Hz, centered on a single, selected hopping channel. The width of a single pulse is measured in a fast scan. The number of pulses is measured in a 0.316 second scan, to enable resolution of each occurrence.

The average time of occupancy in the specified 31.6 second period (79 channels * 0.4 s) is equal to 100 * (# of pulses in 0.316 s) * pulse width.






7.7.1 Conducted Measurement

LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. In addition, radiated emissions which fall in the restricted bands, as defined in §15.205(a), must also comply with the radiated emission limits specified in 15.209(a) (see Section 15.205(c)).

TEST PROCEDURE

Conducted RF measurements of the transmitter output were made to confirm that the EUT antenna port conducted emissions meet the specified limit and to identify any spurious signals that require further investigation or measurements on the radiated emissions site.

The transmitter output is connected to the spectrum analyzer. The resolution bandwidth is set to 100 kHz. The video bandwidth is set to 100 kHz.

Measurements are made over the 30MHz to 25GHz range with the transmitter set to the lowest, middle, and highest channels.





CH Low




CH Mid



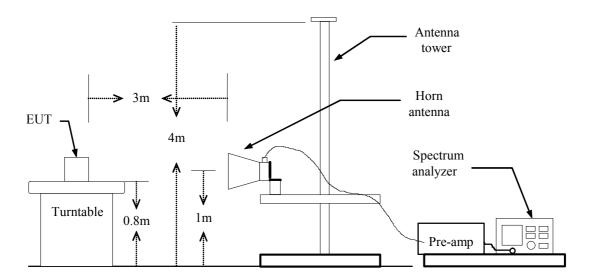

Compliance with the provisions of this paragraph shall be based on the measurement of the radio frequency voltage between each power line and ground at the power terminal. 


