### **EXPOSURE EVALUATION OF PORTABLE DEVICE**

The RF exposure from potable device (47 CFR §2.1091), as defined by FCC, must be evaluated with respect to FCCadopted limits for SAR.

When no other RF exposure testing or reporting are required, a statement of justification and compliance must be included in the equipment approval, in lieu of the SAR report, to qualify for SAR test exclusion.

#### SAR Test Exclusion Thresholds for 100 MHz – 6 GHz and $\leq$ 50 mm

Approximate SAR Test Exclusion Power Thresholds at Selected Frequencies and Test Separation Distances are illustrated in the following Table. The equation and threshold in 4.3.1 must be applied to determine SAR test exclusion.

For 100 MHz to 6 GHz and test separation distances  $\leq$  50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

[(max. power of channel, including tune-up tolerance, mW) / (min. test separation distance, mm)]  $\cdot$  [Vf(GHz)]  $\leq$  3.0 for 1-g SAR, and  $\leq$  7.5 for 10-g extremity SAR.

Worst SAR Test Exclusion Thresholds is < 9.95 mW and 3.0 for separation distance 5mm.

#### Conclusion

The result after calculation is less than or equal to 3, the limit for 1-g SAR, therefore this device is exempt from SAR evaluation.
