




2.4 BLOCK DIAGRAM SHOWING THE CONFIGURATION OF SYSTEM TESTED

3.2 TEST PROCEDURE

a. The EUT is 0.8 m from the horizontal ground plane and 0.4 m from the vertical ground plane with EUT being connected to the power mains through a line impedance stabilization network (LISN). All other support equipments are powered from additional LISN(s). The LISN provides 50 Ohm/ 50uH of coupling impedance for the measuring instrument.

- b. Interconnecting cables that hang closer than 40 cm to the ground plane shall be folded back and forth in the center forming a bundle 30 to 40 cm long.
- c. I/O cables that are not connected to a peripheral shall be bundled in the center. The end of the cable may be terminated, if required, using the correct terminating impedance. The overall length shall not exceed 1 m.
- d. LISN is at least 80 cm from the nearest part of EUT chassis.
- e. For the actual test configuration, please refer to the related Item -EUT Test Photos.






(A) Radiated Emission Test-Up Frequency Below 30MHz

One of the following procedures may be used to determine the maximum peak conducted output power of a DTS EUT.

 $RBW \ge DTS$  bandwidth

The following procedure shall be used when an instrument with a resolution bandwidth that is greater than the DTS bandwidth is available to perform the measurement:

a) Set the RBW  $\geq$  DTS bandwidth.

b) Set VBW  $\geq$  [3 × RBW].

c) Set span  $\geq$  [3 × RBW].

d) Sweep time = auto couple.

e) Detector = peak.

f) Trace mode = max hold.

g) Allow trace to fully stabilize.

h) Use peak marker function to determine the peak amplitude level.

Integrated band power method:

The following procedure can be used when the maximum available RBW of the instrument is less than the

a) Set the RBW = 1 MHz.

b) Set the VBW  $\geq$  [3 × RBW].

c) Set the span  $\geq$  [1.5  $\times$  DTS bandwidth].

f) Trace mode = max hold.


g) Allow trace to fully stabilize.

h) Use the instrument's band/channel power measurement function with the band limits set equal to the DTS bandwidth edges (for some instruments, this may require a manual override to select the peak detector). # 10. FREQUENCY STABILITY

## 10.1 LIMITS OF FREQUENCY STABILITY MEASUREMENT

The frequency tolerance of the carrier signal shall be maintained within +/-0.02% of the operating frequency over a temperature variation of -30 degrees to 50 degrees C at normal supply voltage, and for a variation in primary supply voltage from 85% to 115% of the rated supply voltage at a temperature of 20 degrees.

## **10.2 TEST PROCEDURE**

- 1. The EUT was placed inside the environmental test chamber and powered by nominal DC voltage.
- 2. Turn the EUT on and couple its output to spectrum analyzer.
- 3. Turn the EUT off and set the chamber to the highest temperature specified.
- 4. Allow sufficient time (approximately 30 min) for the temperature of the chamber to stabilize,turn the EUT on and measure the operating frequency after 2,5,and 10 minutes.
- 5. Repeat step 2 and 3 with the temperature chamber set to the lowest temperature.
- 6. The test chamber was allowed to stabilize at +20 degree C for a minimum of 30 minutes. The supply voltage was then adjusted on the EUT from 85% to 115% and the frequency record.
