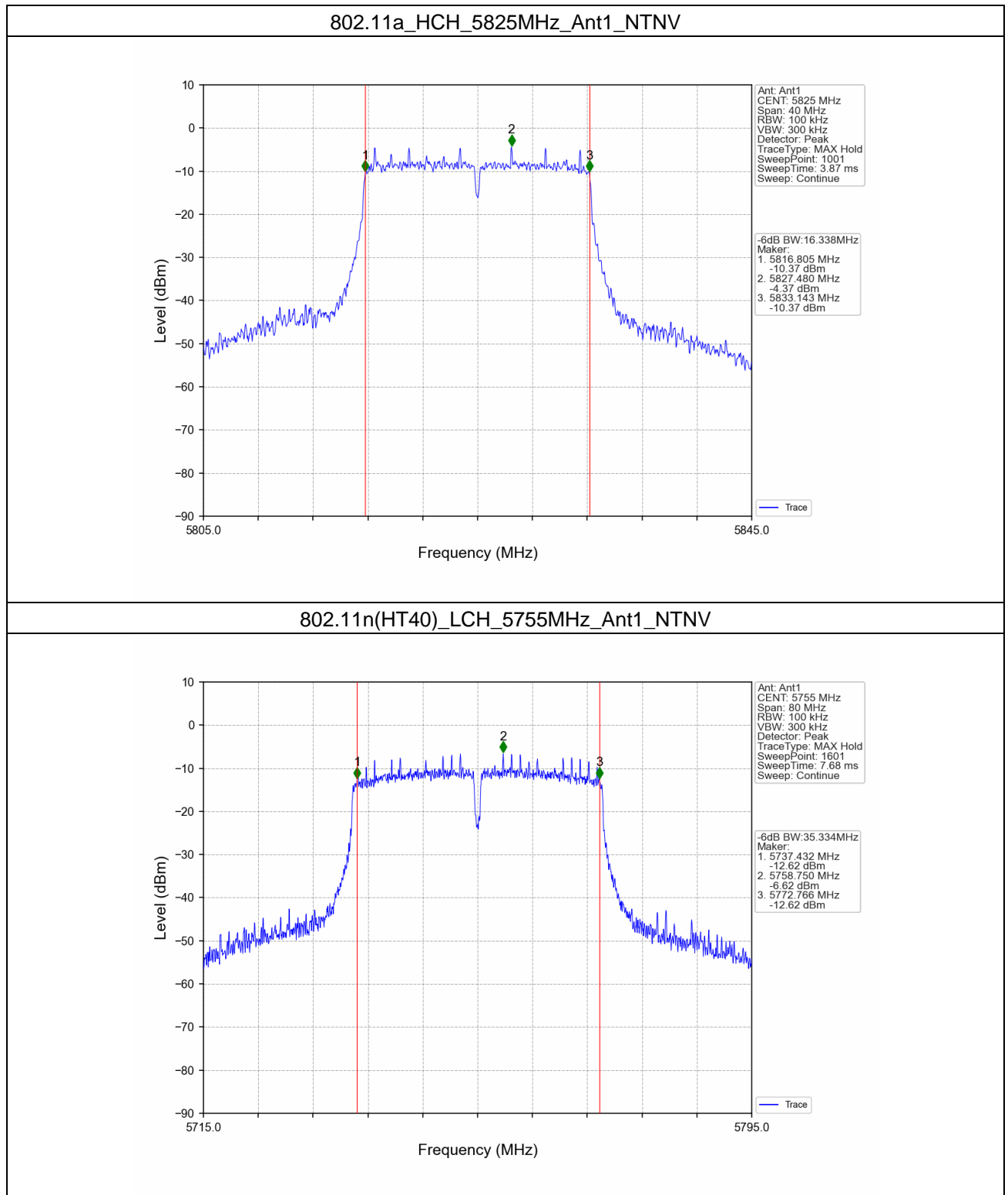
2.2.2 Test Graph

2.3.2 Test Graph



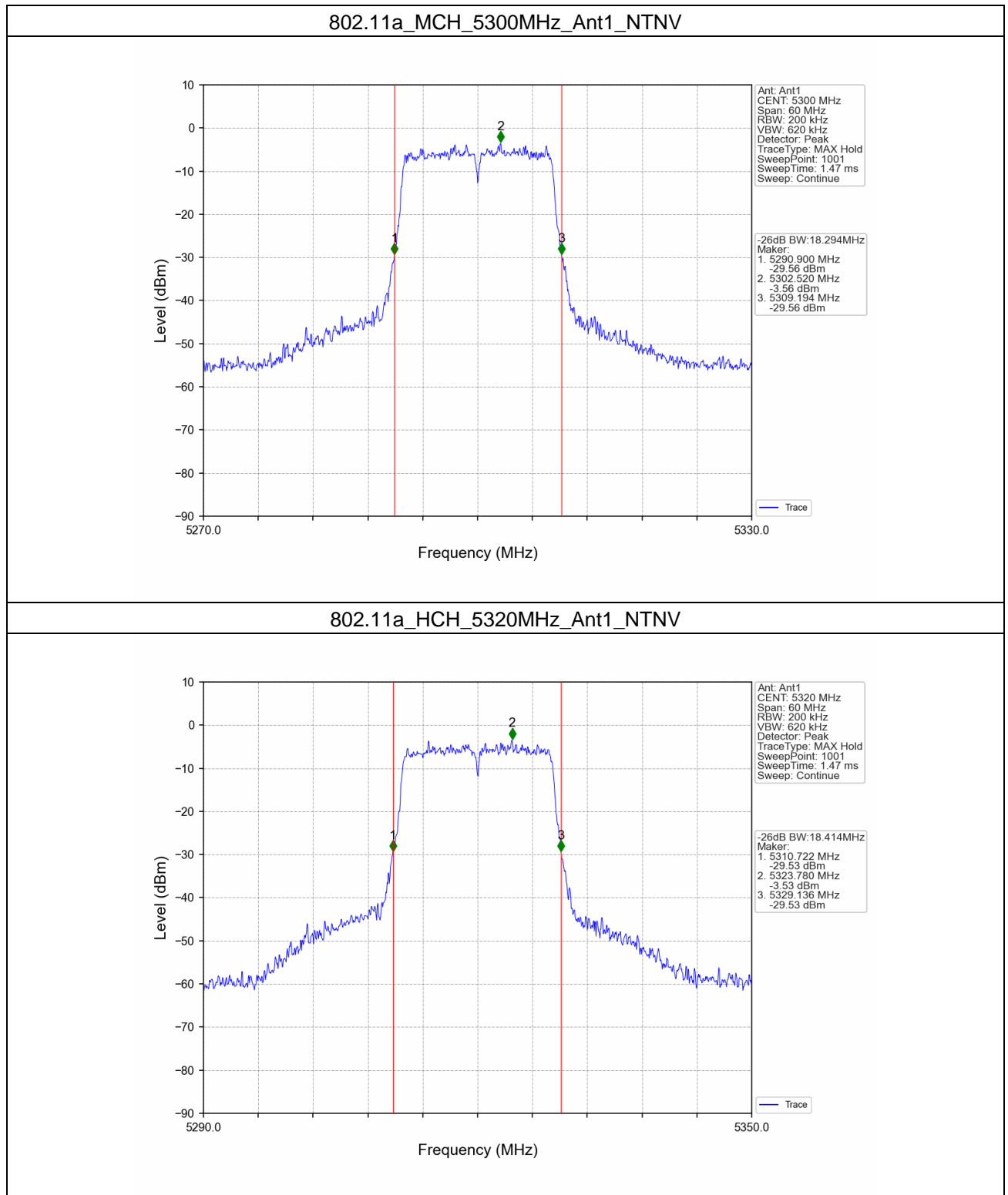
