1. The modular transmitter must have its own RF shielding.	The module has its own RF shielding.
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is integrated in chip RT2880. Please see block diagram. Pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated before energizing other circuits internal to the WI5200. Please see circuit.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The WI5200 meets the FCC antenna requirements. It has a unique connector. Please see external photo.pdf
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The WI5200 was tested in a stand-alone configuration via a USB extender. Please see conducted set-up photo.pdf and spurious set-up photo.pdf

The modular transmitter must be labeled with its own FCC ID number, and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements. A copy of these instructions must be included in the application for equipment authorization.	The WI5200 is compliant with all applicable FCC rules. Detail instructions are given in the Users Manual. 8. The modular transmitter must comply with any applicable RF exposure requirements.
