






### 1.1.5 Transmitter Radiated Unwanted Emissions (Below 30 MHz)







#### 1.1.6 Results of Radiated Emissions (30 MHz – 1 GHz)






#### 1.1.7 Results for Radiated Emissions (1 GHz - 10th Harmonic)
