After a review of the submitted information, I have a few comments on the above referenced Application.

- 1) The FCC ID number must be preceded by "FCC ID:". Please correct the FCC Label.
- 2) The RF exposure statements do not appear to be provided in the users manual. Please provide a corrected users manual that includes this information.
- Section III of the test report states that the device contains a permanently attached antenna. Please note that the EUT shows a connector internal to the device, but is not permanently attached. Please adjust this section as necessary.
- Note 1 on page 19/36 of the test report references a RBW of 300 kHz. This is incorrect. This should be 100 kHz. Please correct.
- 5) The device is also subject to a DoC authorization as shown by its label. However the information specified by 2.1077 (see below) must be provided either in the users manual or as an additional insert to the packaging. Please note that all this information <u>must be on the same page</u>. This information could not be found. Please comment and provide either a corrected users manual or a copy of the compliance sheet.

COMPLIANCE INFORMATION (47CFR 2.1077)

If a product is tested and authorized under a Declaration of Conformity, a compliance information statement shall be supplied with the product at the time of marketing or importation, containing the following information:

(1) Identification of the product, i.e. name and model number.

(2) A statement similar to that contained in Section 15.19(a)(3) that the product complies with Part 15 of the regulations.

(3) The identification, by name, address and telephone number, of the responsible party. The responsible party is defined as either the manufacturer, or if the equipment is imported, the importer. The responsible party for a Declaration of Conformity must be located within the United States.

6) FYI, Please note that DSS spread spectrum systems are now considered to be defined as "DTS" for purposes of the equipment code given in section 4(a) of the 731 form.
