


#### Description of EUT Operation:

The Equipment Under Test (EUT) is a CABEN ASIA PACIFIC LTD of Radio Control toy. The EUT is superregenerative receiver and operating at 49.8596MHz.

#### Antenna Requirement (Section 15.203)

The EUT is use of a permanently antenna. The antenna consists of 48.0cm long single wire. It is soldered on the PCB. The antenna is not replaceable or user serviceable. The requirement of S15.203 are met. There are no deviations or exceptions to the specifications.


### Test Procedure:

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables. For battery operated equipment, the equipment tests shall be perform using new battery. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is place 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1m above the ground.





Inner Circuit Bottom View








