- 1. Below 1GHz, the channel 1, 6, and 11 were pre-tested in chamber. The channel 11, the worst case, was chosen for final test.
- 2. Above 1GHz, the channel 1, 6, and 11 were tested individually.
- 3. For radiated emission measurement below 1GHz, transfer rate at 11Mbps with CCK technique and 6Mbps with OFDM technique, worst cases, were chosen for final test.

3.3 GENERAL DESCRIPTION OF APPLIED STANDARDS

The EUT is a 54Mbps/11Mbps Wireless ADSL Router. According to the specifications of the manufacturer, it must comply with the requirements of the following standards:



4.1.3 TEST PROCEDURES


- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150kHz to 30MHz was searched. Emission levels over 10dB under the prescribed limits could not be reported

4.1.6 EUT OPERATING CONDITIONS

- a. Placed the EUT on the testing table.
- b. The computer system sent data to EUT by command "PING" via RJ45 cable.
- c. The computer system sent "H" messages to Color Monitor and Monitor displayed "H" patterns on its screen.
- d. The computer system sent "H" messages to modem.
- e. The computer system sent "H" messages to the printer, and the printer prints them on paper.
- f. Prepared another computer system to act as a communication partner and placed it outside of testing area.
- g. The communication partner ran a test program to enable EUT under transmission/receiving condition continuously at specific channel frequency via RJ45 cable.
- h. The communication partner sent data to EUT by command "PING".



4.2.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

4.5.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3kHz RBW and 30kHz VBW, set sweep time=span/3kHz. The power spectral density was measured and recorded.

The sweep time is allowed to be longer than span/3KHz for a full response of the mixer in the spectrum analyzer.

For CCK technique: The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 1MHz and 300Hz with suitable frequency span including 100MHz bandwidth from band edge. The band edges was measured and recorded.




NOTE 1: The band edge emission plot of the CCK technique on the following two pages show 53.34dB/50.39dB delta between carrier maximum power and local maximum emission in restrict band (2.3889GHz/2.4844GHz). The emission of carrier strength list in the test result of channel 1 and 11 at the item 4.2.7 are 91.85dBuV/m and 92.6BuV/m, so the maximum field strength in restrict band is 92.6-50.39=42.21dBuV/m which is under 54dBuV/m limit.

NOTE 2: The band edge emission plot of the OFDM technique on the following 3~4 pages show 46.48dB/48.23dB delta between carrier maximum power and local maximum emission in restrict band (2.3900GHz/2.4844GHz). The emission of carrier strength list in the test result of channel 1 and 11 at the item 4.2.7 are 91.24dBuV/m and 92.25BuV/m, so the maximum field strength in restrict band is 91.24-46.48=44.76dBuV/m which is under 54dBuV/m limit.





















4.7 ANTENNA REQUIREMENT










RADIATED EMISSION TEST
