







4.5.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator, the bandwidth of the fundamental frequency was measured with the spectrum analyzer using 3 kHz RBW and 30 kHz VBW, set sweep time=span/3kHz. The power spectral density was measured and recorded.

The sweep time is allowed to be longer than span/3KHz for a full response of the mixer in the spectrum analyzer.

4.6.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer via a low lose cable. Set both RBW and VBW of spectrum analyzer to 100 kHz with suitable frequency span including 100 kHz bandwidth from band edge. The band edges was measured and recorded.



The spectrum plots are attached on the following 4 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).


NOTE (1): The band edge emission plot on the following first page shows 56.81dB delta between carrier maximum power and local maximum emission in restrict band (2.3758GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.8 is 99.52dBuV/m, so the maximum field strength in restrict band is 99.52-56.81=42.71dBuV/m which is under 54 dBuV/m limit.

NOTE (2): The band edge emission plot on the following third page shows 55.78dB delta between carrier maximum power and local maximum emission in restrict band (2.4889GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.8 is 99.42dBuV/m, so the maximum field strength in restrict band is 99.42-55.78=43.64dBuV/m which is under 54 dBuV/m limit.










NOTE (1): The band edge emission plot on the following first page shows 50.24dB delta between carrier maximum power and local maximum emission in restrict band (2.3756GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.9 is 94.51dBuV/m, so the maximum field strength in restrict band is 94.51-50.24=44.27dBuV/m which is under 54 dBuV/m limit.


NOTE (2): The band edge emission plot on the following third page shows 48.24dB delta between carrier maximum power and local maximum emission in restrict band (2.4837GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.9 is 94.97dBuV/m, so the maximum field strength in restrict band is 94.97-48.24=46.73dBuV/m which is under 54 dBuV/m limit.





















4.7 ANTENNA REQUIREMENT

4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

4.7.2 ANTENNA CONNECTED CONSTRUCTION

The antenna types used in this product is external antennas without connector. The maximum Gain of this antenna is 0.5dBi.
