1 MPE EVALUATION OF MOBILE DEVICES

MPE Evaluation of Simultaneous Transmission

2.4 and 5GHz can transmit at the same time, MPE evaluation is as below formula

PD1 / Limit1 + PD2 / Limit 2 + < 1, PD = Power density

Non-beamforming mode

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz (B1) + Maximum MPE of 5 GHz (B4) = 0.077 / 1 + 0.162 / 1 + 0.535 / 1 = 0.775 < 1

Non-beamforming mode 2.4G+ 5G(B1) + Beamforming mode 5G(B4)

MPE Evaluation = Maximum MPE of 2.4GHz + Maximum MPE of 5 GHz (B1) + Maximum MPE of 5 GHz (B4) = <math>0.077 / 1 + 0.162 / 1 + 0.729 / 1 = 0.968 < 1
