



4.1.1 LIMITS OF OUTPUT POWER MEASUREMENT

Per FCC Part 90.542(a)(6)(7),

Control stations and mobile stations transmitting in the 763–768 MHz band and the 793–798 MHz band are limited to 30 watts ERP.

Portable stations (hand-held devices) transmitting in the 763–768 MHz band and the 793–798 MHz band are limited to 3 watts ERP.


4.1.3 TEST PROCEDURES

ERP MEASUREMENT:

- a. The EUT was set up for the maximum power with LTE link data modulation. The power was measured with Angilent Spectrum Analyzer. All measurements were done at 1 channel. RWB and VBW is 5MHz for LTE
- b. E.I.R.P power measurement. In the semi-anechoic chamber, EUT placed on the 0.8m height of Turn Table, rotated the table around 360 degrees to search the maximum radiation power and receiver antenna shall be rotated vertical and horizontal polarization and moved height from 1m to 4m to find the maximum polar radiated power. The "Read Value" is the spectrum reading the maximum power value.
- c. The substitution horn antenna is substituted for EUT at the same position and signals generator export the CW signal to the substitution antenna via a TX cable. Rotated the Turn Table and moved receiving antenna to find the maximum radiation power. Adjust output power level of S.G to get a Value of spectrum reading equal to "Read Value" of step a. Record the power level of S.G
- d. EIRP = Output power level of S.G TX cable loss + Antenna gain of substitution horn
- e. E.R.P = E.I.R.P- 2.15 dB




4.2.3 TEST PROCEDURE

- a. The oven room could control the temperatures and humidity.
- b. Power must be removed when changing from one temperature to another or one voltage to another voltage. Power warm up is at least 15 min and power applied should perform before recording frequency error.





4.7 RADIATED EMISSION MEASUREMENT

4.7.1 LIMITS OF RADIATED EMISSION MEASUREMENT

- (1)The power of any emission outside a licensee's frequency block shall be attenuated below the transmitter power (P) by at least 43 +10 log10(P) dB. The limit of emission equal to -13dBm


