#### **MPE Evaluation of Simultaneous Transmission**

WLAN 2.4 and WLAN 5GHz can transmit at the same time, MPE evaluation is as below formula PD1 / Limit1 + PD2 / Limit 2 + ..... < 1, PD = Power density

MPE Evaluation = Maximum MPE of WLAN 2.4GHz + WLAN 5GHz = 0.177 / 1 + 0.323 / 1 = 0.5 < 1
