#### 1 MPE EVALUATION OF MOBILE DEVICES

#### **MPE Evaluation of Simultaneous Transmission**

MPE evaluation is as below formula

MPE Evaluation = 0.055 / 1 + 0.119 / 1 = 0.174 < 1
