



4.2 FREQUENCY STABILITY MEASUREMENT

4.2.1 LIMITS OF FREQUENCY STABILITY MEASUREMENT

According to the FCC part 2.1055 shall be tested the frequency stability. The rule is defined that" The frequency stability shall be sufficient to ensure that the fundamental emission stays within the authorized frequency block." The test extreme voltage is according to the 2.1055(d)(1) Vary primary supply voltage from 85 to 115 percent of the nominal value for other than hand carried battery equipment and the extreme temperature rule is comply with specification of EUT 0° C $\sim 40^{\circ}$ C.



4.2.3 TEST PROCEDURE

- a. Power must be removed when changing from one temperature to another or one voltage to another voltage. Power warm up is at least 15 min and power applied should perform before recording frequency error.
- b. EUT is connected the external power supply to control the AC input power. The various Volts from the minimum 93.5 Volts to 126.5 Volts. Each step shall be record the frequency error rate.
- c. The temperature range step is 10 degrees in this test items. All temperature levels shall be hold the $\pm 0.5^{\circ}$ C during the measurement testing.
- d. The each temperature step shall be at least 0.5 hours, consider the EUT could be test under the stability condition.

4.3 EMISSION BANDWIDTH MEASUREMENT

4.3.1 LIMITS OF EMISSION BANDWIDTH MEASUREMENT

According to FCC 27.53(m)(6) specified that emission bandwidth is defined as the width of the signal between two points, one below the carrier center frequency and one above the carrier center frequency, outside of which all emissions are attenuated at least 26dB below the transmitter power.



4.3.3 TEST PROCEDURE

The transmitter output was connected to the spectrum analyzer through an attenuator. The bandwidth of the fundamental frequency was measured by spectrum analyzer with RBW = 51kHz, VBW = 160kHz (for channel bandwidth 5MHz), RBW = 100kHz, VBW = 300kHz (for channel bandwidth 10MHz). The 26dB bandwidth is defined as the total spectrum the power of which is higher than peak power minus 26dB.










MIDDLE CHANNEL



HIGH CHANNEL







4.4 CHANNEL EDGE MEASUREMENT
