## REQUEST FOR A FURTHER EXTENSION OF TIME IN WHICH TO SUPPLEMENT PETITION FOR RECONSIDERATION

For the reasons set forth below, Kohler Co. ("Kohler"), by its attorneys, hereby requests an extension of time, through and including January 31, 2000, in which to supplement its pending Petition for Reconsideration and Motion for Partial Stay in the above-referenced matter.

On November 23, 1999, Kohler Co. filed its Petition for Reconsideration and Motion for Partial Stay ("Petition") of the action taken on October 28, 1999 by Rich Fabina, Chief of the Commission's Equipment Authorization Branch, setting aside the referenced Grant of Equipment Authorization previously issued to Kohler Co. and

requesting a return to the Commission of the original Grant of Equipment Authorization. At the same time, pursuant to Section 1.106(f), 47 C.F.R. § 1.106(f), Kohler submitted its Request for Leave to Supplement Petition for Reconsideration. In that Request, which was granted by the Chief, Laboratory Division, of the Commission's Office of Engineering and Technology, Kohler requested permission to supplement its Petition for Reconsideration through and including December 31, 1999. The basis for Kohler's request, as indicated in both the Petition and the Request for Leave to Supplement, was Kohler's desire to resolve this matter informally and to avoid, for both itself and the Commission, the unnecessary expenditure of time and resources in formally pursuing this matter

Kohler continues to believe that this matter should be resolved informally and, to that end, is actively working with appropriate Commission staff members. To permit those discussions to continue unencumbered by the expenditure of time and resources that would be necessary on Kohler's part to fully prosecute the Petition for Reconsideration and, on the Commission's part, to resolve the issues raised in the Petition, Kohler believes that a further period in which to supplement its Petition would be appropriate. Accordingly, pursuant to Section 1.106(f), 47 C.F.R. § 1.106(f), Kohler

hereby requests that it be granted a further extension of time, through and including

January 31, 2000, in which to supplement its Petition for Reconsideration.
