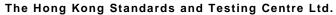

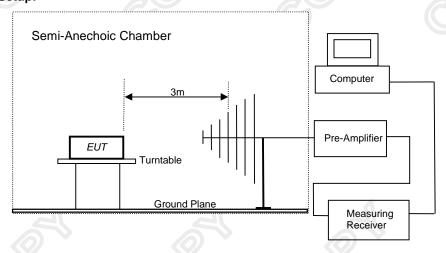

Test Method:

The sample was placed 0.8m above the ground plane of semi-anechoic Chamber*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigated all operating modes, rotated about all 3 axis (X, Y & Z) and considered typical configuration to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

Where F is the frequency in MHz, the formula for calculating the maximum permitted fundamental field strengths are as follows: for the band 130-174 MHz, mV/m at 3 meters=22.72727(F)-2454.545; for the band 260-470 MHz, mV/m at 3 meters =16.6667(F)-2833.3333. The maximum permissible unwanted emission level is 20dB below the maximum fundamental level.

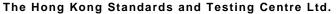

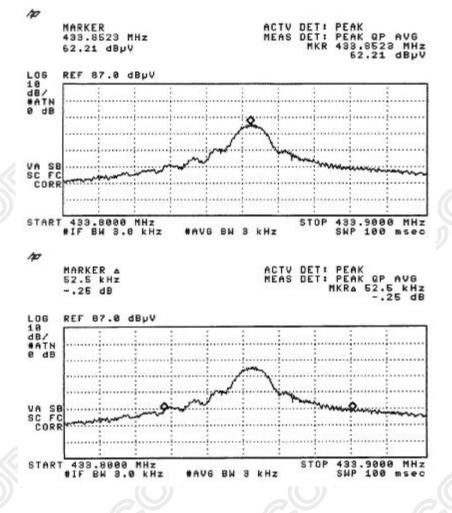

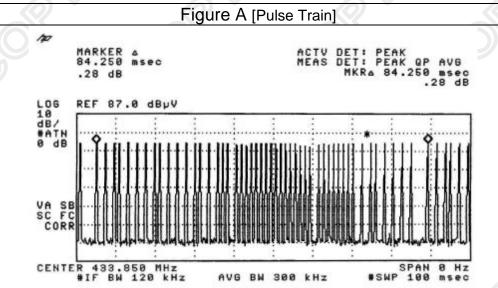
Duty Cycle Correction During 100msec

Each function key sends a different series of characters, but each packet period (84.25msec) never exceeds a series of 49 long (150μ sec) or 49 short (100μ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered $49x150\mu$ sec per 84.25msec=8.7% duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction = 20Log(0.087) =-21.1dB

Figure B [Long Pulse]

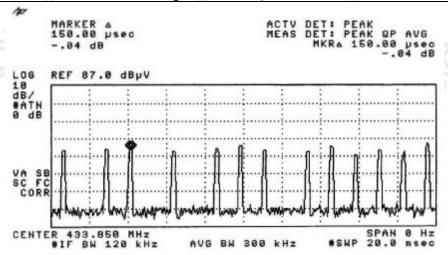
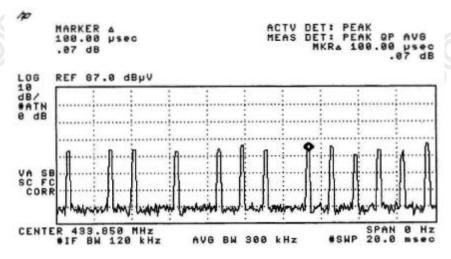


Figure C [Short Pulse]

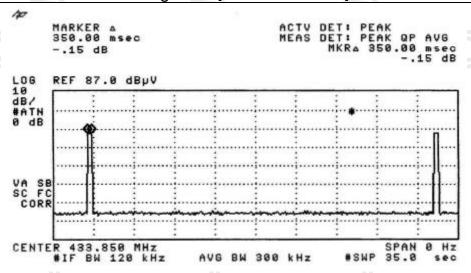
According to FCC 47CFR15.231e. The EUT shall be provided with a means for automatically limiting operation so that the duration of each transmission shall not be greater than one second and the silent period between transmissions shall be at least 30 times the duration of the transmission but in no case less than 10 seconds.

Results:

Since the EUT of each transmission is 350msec, so the silent period must not less than 10.5 seconds (350msec x 30).

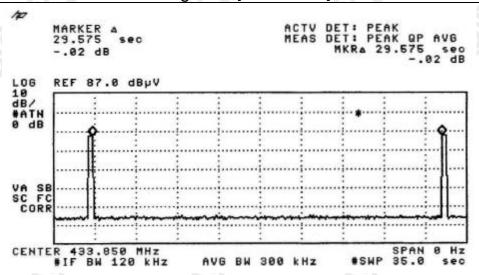

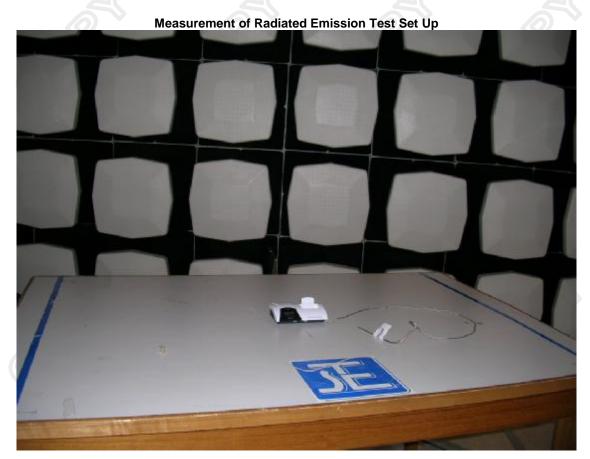
