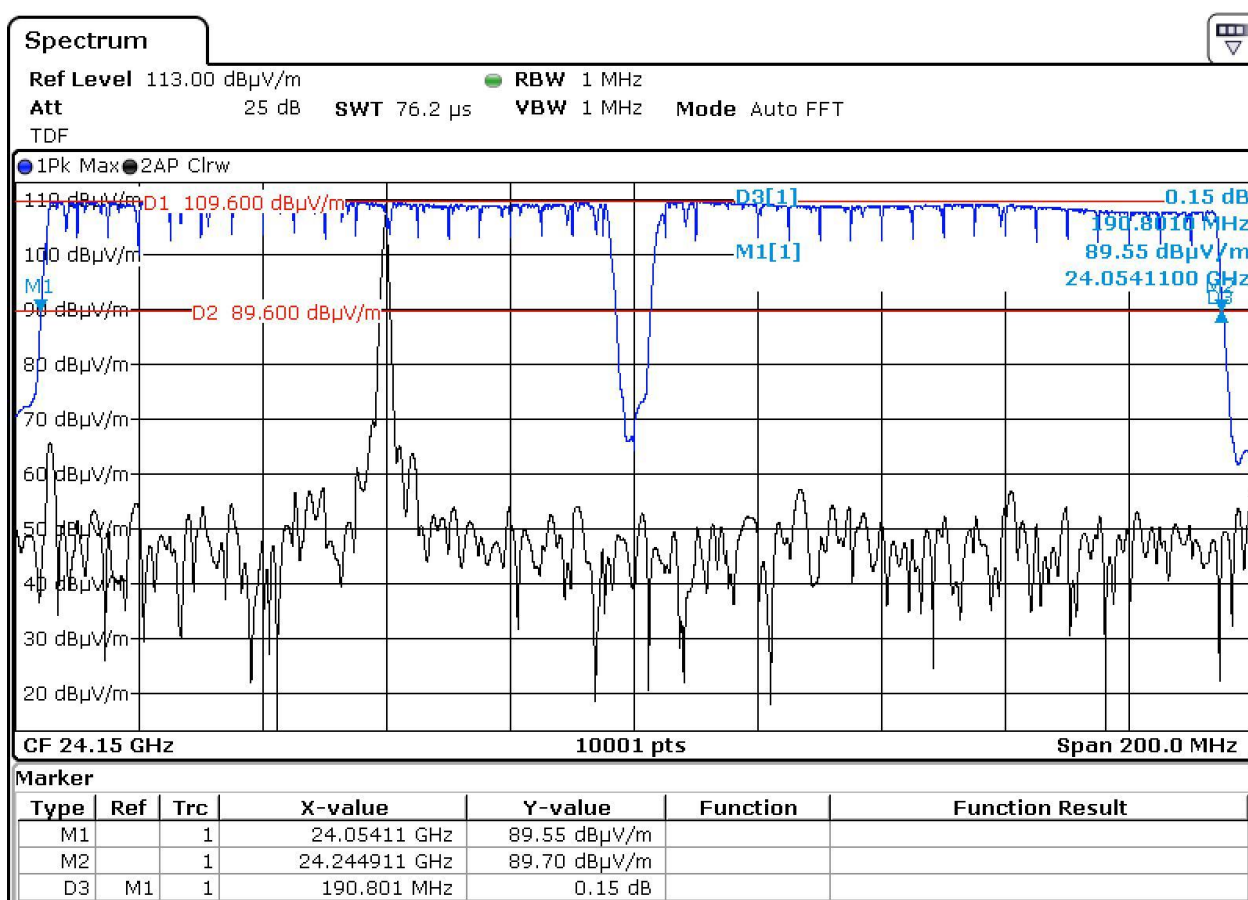

Plots for the test equipment (EUT) – Measured 20 dB Bandwidth



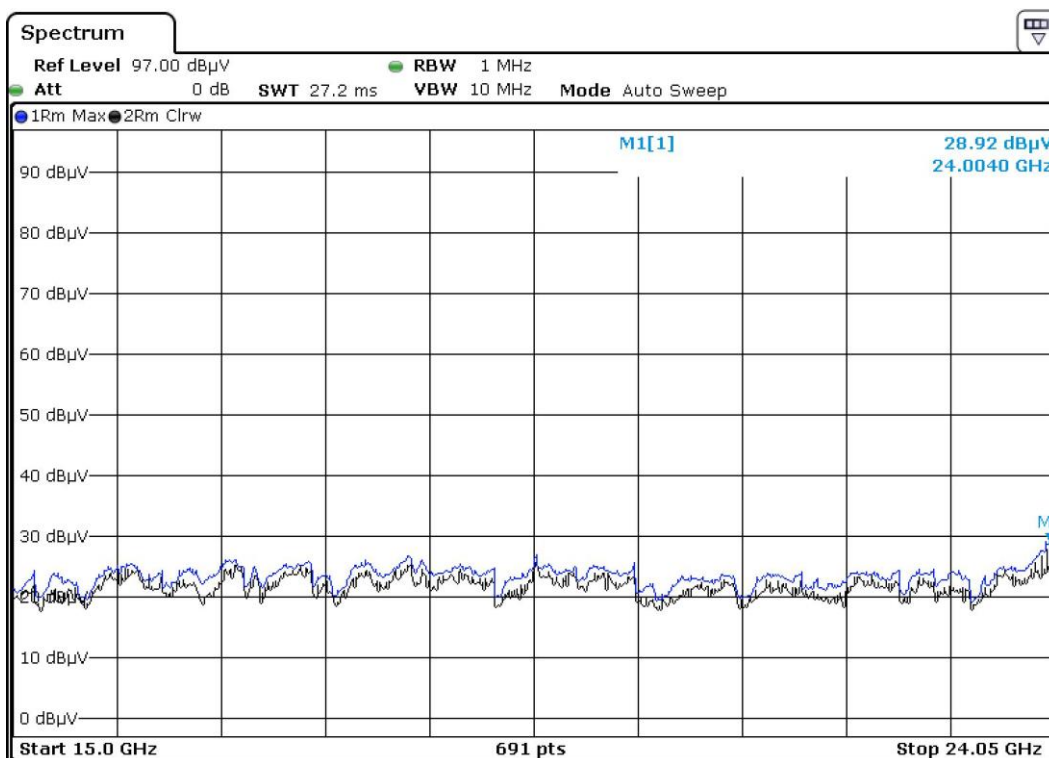
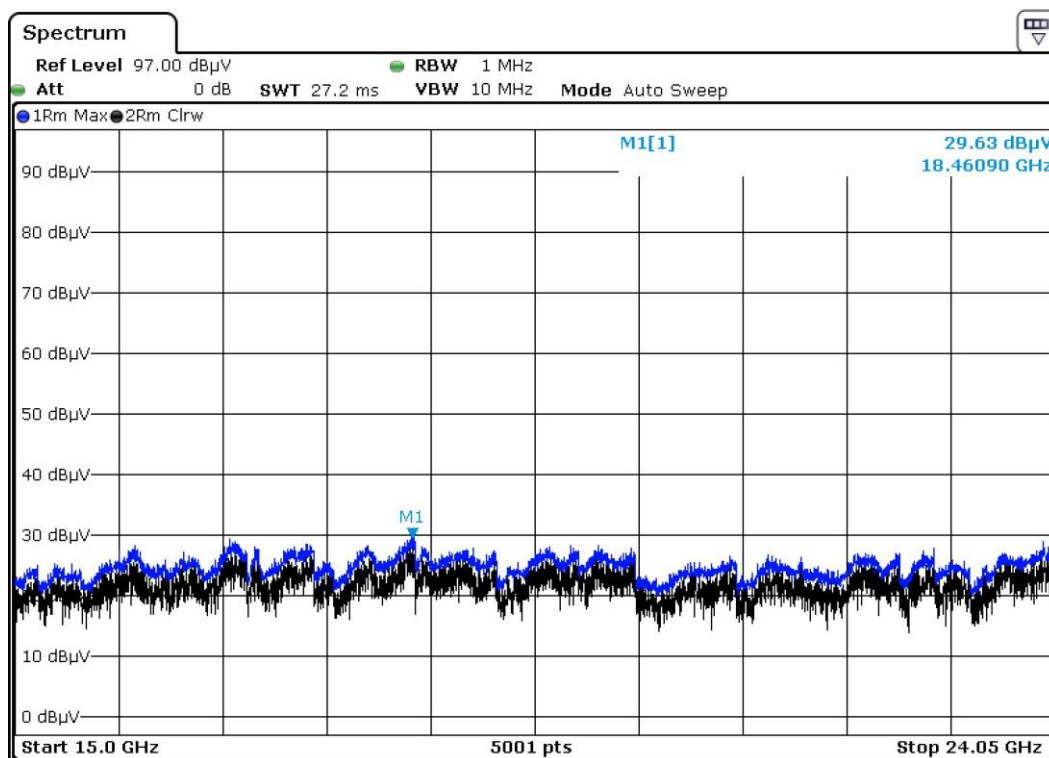

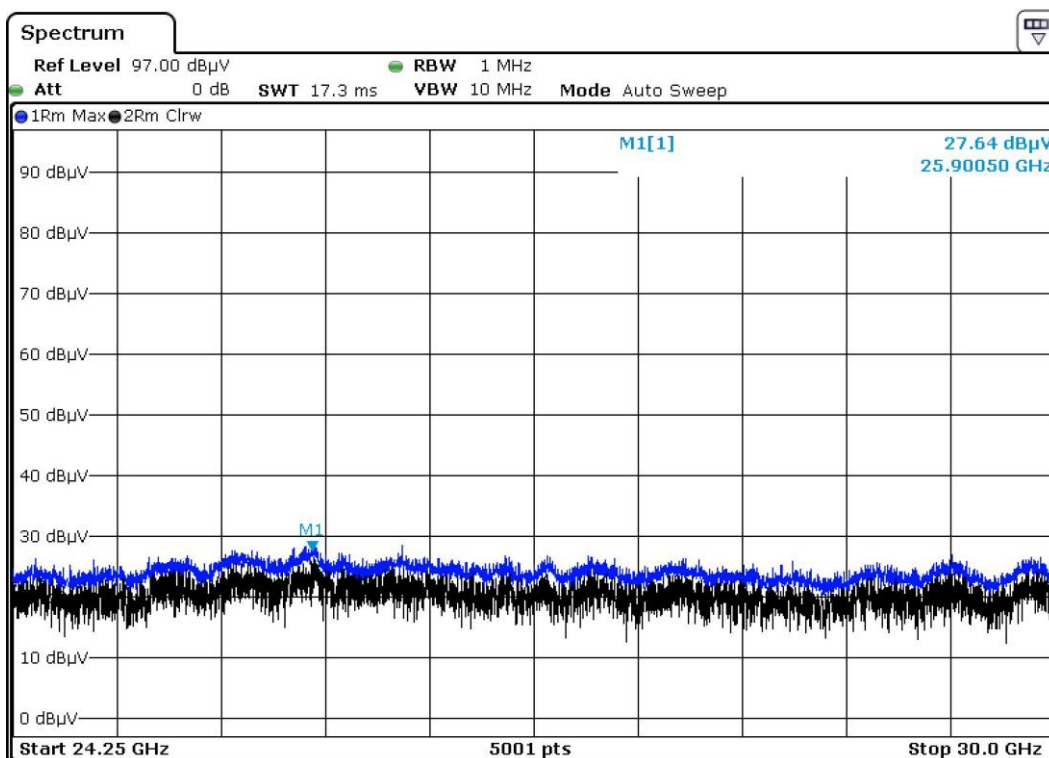
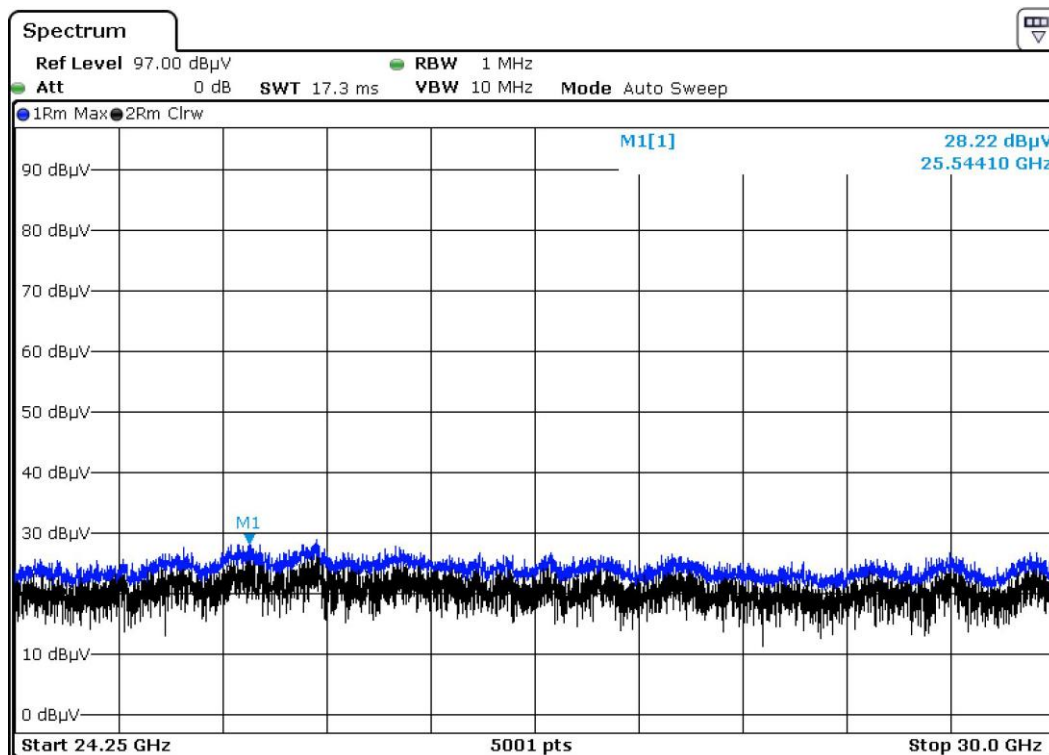
Plots for the test equipment (EUT) – 24-30 GHz Horizontal and vertical - Master
