The letter references §§ 0.457 (d) and 0.459 of the FCC Rules as the authority for requesting confidentiality. Hella GmbH & Co., KgGaA would like to acquire long term confidentiality regarding the **Non-Disclosure Agreement (NDA)** documents itself and the Internal Photos under this submission for FCC ID: **NBG01RS53**;

The aforementioned request of confidentiality is submitted because internal photos contain RF integrated circuits board layout patterns, antenna designs and antenna distribution networks, which are trade secrets and shall not be accessible to users or the public. The devices cannot be opened without special tools. In addition, the device is not being sold separately from the vehicle. The installation of the device can only be installed through licensed distributors under NDA. For these items, Hella GmbH & Co., KgGaA has signed NDA documents with customers and/or suppliers. Therefore, internal photos submitted to FCC shall never be available publicly or disclosed to unauthorized persons. Only Hella GmbH & Co., KgGaA employees have access to these photos and devices, or customers under NDA. All the sales for these devices must be under NDA, restricting the disclosure of the propriety information including internal photos.
