 4. The document entitled "MIFI2352 FCC/IC Deliverables" lists an emission designator and a max power rating for cellular (850 MHz) WCDMA. Elsewhere in this application it is indicated that the EUT does not support this band. Please clarify, and revise as necessary.
 5. Please submit the MPE report for the EUT.
