Exposure Information to Radio Frequency Energy

This PCMCIA card has been tested in 3 different notebooks for compliance with the SAR requirements.

Measured SAR values according to the CE regulations:

The maximum measured body SAR value (averaged over a mass of 10 g and distance between phantom and antenna of 15 mm) is well below the limit of 2 W/kg.

Measured SAR values according to the FCC regulations:
