- 1. Below 1 GHz, the channel 1, 6, and 11 were pre-tested in chamber. The channel 11, worst case one, was chosen for final test.
- 2. Above 1 GHz, the channel 1, 6, and 11 were tested individually.

3.3 GENERAL DESCRIPTION OF APPLIED STANDARDS

The EUT is a Wireless Compact Flash Card. According to the specifications of the manufacturer, it must comply with the requirements of the following standards:

FCC CFR 47 Part 15, Subpart C. (15.247) ANSI C63.4: 1992

All tests have been performed and recorded as per the above standards.

NOTE: The EUT is also considered as a kind of computer peripheral, because the connection to computer is necessary for typical use. It has been verified to comply with the requirements of FCC Part 15, Subpart B, Class B (DoC). The test report has been issued separately.



4.1.3 TEST PROCEDURES

- a. The EUT was placed 0.4 meters from the conducting wall of the shielded room with EUT being connected to the power mains through a line impedance stabilization network (LISN). Other support units were connected to the power mains through another LISN. The two LISNs provide 50 ohm/ 50uH of coupling impedance for the measuring instrument.
- b. Both lines of the power mains connected to the EUT were checked for maximum conducted interference.
- c. The frequency range from 150 kHz to 30 MHz was searched. Emission levels over 10dB under the prescribed limits could not be reported

4.1.4 TEST SETUP



Note: 1. Support units were connected to second LISN.

2. Both of LISNs (AMIN) 80 cm from EUT and at the least 80 cm from other units and other metal planes support units.

- e. The computer system sent "H" messages to printer and the printer prints them on paper.




4.2.3 TEST PROCEDURES

- a. The EUT was placed on the top of a rotating table 0.8 meters above the ground at a 10 meter open area test site. The table was rotated 360 degrees to determine the position of the highest radiation.
- b. The EUT was set 3 meters away from the interference-receiving antenna, which was mounted on the top of a variable-height antenna tower.
- c. The antenna is a broadband antenna, and its height is varied from one meter to four meters above the ground to determine the maximum value of the field strength. Both horizontal and vertical polarizations of the antenna are set to make the measurement.
- d. For each suspected emission, the EUT was arranged to its worst case and then the antenna was tuned to heights from 1 meter to 4 meters and the rotatable table was turned from 0 degrees to 360 degrees to find the maximum reading.
- e. The test-receiver system was set to Peak Detect Function and Specified Bandwidth with Maximum Hold Mode.
- f. If the emission level of the EUT in peak mode was 10 dB lower than the limit specified, then testing could be stopped and the peak values of the EUT would be reported. Otherwise the emissions that did not have 10 dB margin would be re-tested one by one using peak, quasi-peak or average method as specified and then reported in a data sheet.

- 1. The resolution bandwidth and video bandwidth of test receiver/spectrum analyzer is 120kHz for Peak detection (PK) and Quasi-peak detection (QP) at frequency below 1GHz.


The spectrum plots are attached on the following 2 pages. D2 line indicates the highest level, D1 line indicates the 20dB offset below D2. It shows compliance with the requirement in part 15.247(C).

NOTE1: The band edge emission plot on the following first page shows 50.38dB delta between carrier maximum power and local maximum emission in restrict band (2.3806GHz). The emission of carrier strength list in the test result of channel 1 at the item 4.2.6 is 92.4dBuV/m, so the maximum field strength in restrict band is 92.4-50.38=42.02 dBuV/m which is under 54 dBuV/m limit.

NOTE2: The band edge emission plot on the following second page shows 47.09dB delta between carrier maximum power and local maximum emission in restrict band (2.4836GHz). The emission of carrier strength list in the test result of channel 11 at the item 4.2.6 is 91.2dBuV/m, so the maximum field strength in restrict band is 91.2-47.09=44.11 dBuV/m which is under 54 dBuV/m limit.









4.7 ANTENNA REQUIREMENT

4.7.1 STANDARD APPLICABLE

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

And according to FCC 47 CFR Section 15.247 (b), if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

4.7.2 ANTENNA CONNECTED CONSTRUCTION

The antenna used in this product is Ceramic Antenna. There is no antenna connector. And the maximum Gain of this antenna is only 0dBi.


CONDUCTED EMISSION TEST








RADIATED EMISSION TEST
