- 2. PC runs a test program to enable all functions.
- 3. PC reads and writes messages from FDD and HDD.
- 4. PC sends "H" messages to monitor and monitor displays "H" patterns on screen.
- 5. PC sends "H" messages to modem.
- 6. PC sends "H" messages to printer, and the printer prints them on paper.
- 7. Repeat steps 3-7.




