I have been assigned to review this application. The following questions must be answered before processing can continue:

1. The confidentiality request letter asks that the test report be kept confidential. Please submit a revised confidentiality request letter with the test report request removed.

2. Please submit an FCC ID label photo or label drawing

**Ans: Please have the FCC ID label smp and location.**

3. Per section 2.1033(b)4 of the Rules, please submit a revised operational description that contains a short description of the circuit functions of this device, including a description of modulation type

**Ans: Please have the revised OpDes.**

4. Per section 2.1033(b)5 of the Rules, please submit a block diagram for the transmitter alone. The block diagram needs to show the frequency of all oscillators in the device and the signal paths.

**Ans: Please have the Block diagram.**

5. Section 13.1.4.1(c) of ANSI C63.4 - 2003 requires that a device of this type be tested for radiated emissions with the EUT operating in each of 3 orthogonal axes, i.e., radiated emissions need to be measured for EUT resting on X axis, Y axis, and Z axis. Only one EUT orientation is shown in the test report and in the test set-up photos.
