2. The modular transmitter must have buffered modulation/data inputs (if such inputs are provided) to ensure that the module will comply with Part 15 requirements under conditions of excessive data rates or over-modulation.	Buffered data inputs stage has been integrated in chip MT7668AUN.
3. The modular transmitter must have its own power supply regulation.	The model name of the power regulator is RT8096C.

The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements.
