1 General Description

1.1 Information

This is a Class II Permissive Change report. (C2PC).

This report is issued as a supplementary report to the original report no. FA271305

The change of the EUT is listed as the following of hardware modification of non-RF section:

- 1. Add a Schottky diode to protect LDO voltage regulator.
- 2. Add a level shifter on UART6_RX
- 3. Add a 5V net to connector
- 4. PCB layout is modified for above change

2 RF Exposure Test Exemptions

2.1 1-mW TEST EXEMPTION

Available maximum time-averaged power is no more than 1 mW.

2.2 SAR-BASED EXEMPTION

This exemption is applicable to the frequency range between 300 MHz and 6 GHz, with test separation distances between 0.5 cm and 40 cm, and for all RF sources in fixed, mobile, and portable device exposure conditions.
