## 2.6 TRANSMIT POWER CONTROL (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW.

Maximum EIRP of this device is 101.625 mW which less than 500mW, therefore it's not require TPC function.

## 2.7 STATEMENT OF MAUNFACTURER

Manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. And the device doesn't have Ad Hoc mode on DFS frequency band.



# 3. U-NII DFS RULE REQUIREMENTS

## 3.1 WORKING MODES AND REQUIRED TEST ITEMS

The manufacturer shall state whether the EUT is capable of operating as a Master and/or a Client. Note 3: During the U-NII Detection Bandwidth detection test, radar type 1 is used and for each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.



### PARAMETERS OF DFS TEST SIGNALS

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.

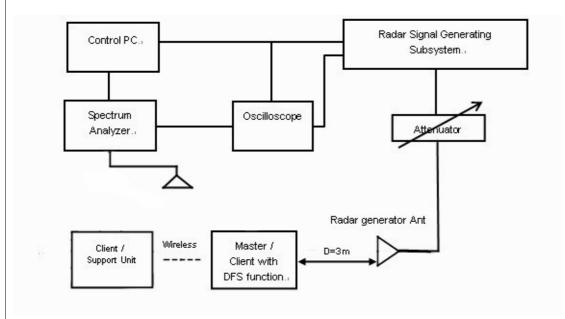


# 5. TEST PROCEDURE

## 5.1 ADT DFS MEASUREMENT SYSTEM:

A complete ADT DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 10, 11 and 12. The traffic monitoring subsystem is specified to the type of unit under test (EUT).

## Radiated setup configuration of ADT DFS Measurement System



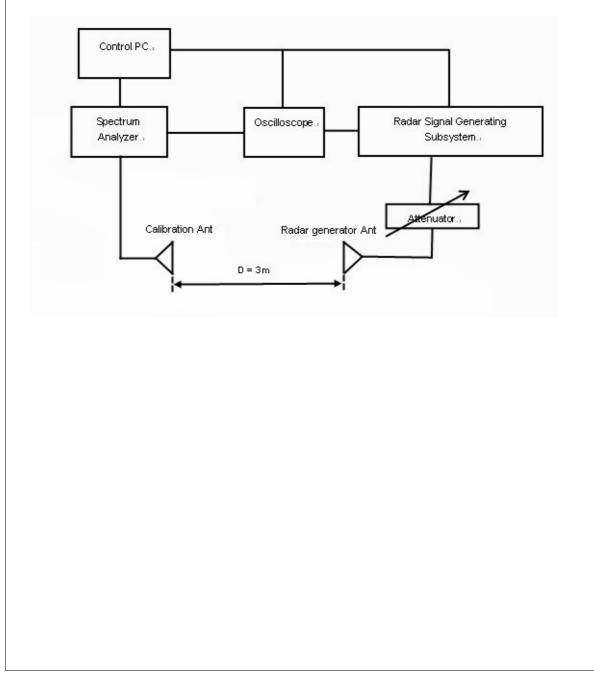
The test transmission will always be from the Master Device to the Client Device. While the Client device is set up to associate with the Master device and play the MPEG file ( $6\frac{1}{2}$  Magic Hours) from Master device, the designated MPEG test file and instructions are located at: http://ntiacsd.ntia.doc.gov/dfs/.



## 5.2 CALIBRATION OF DFS DETECTION THRESHOLD LEVEL:

The measured channel is 5500MHz and 5510MHz, The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The Master minimum antenna gain is 4.0 dBi, and required detection threshold is -64 dBm.

## Radiated setup configuration of Calibration of DFS Detection Threshold Level



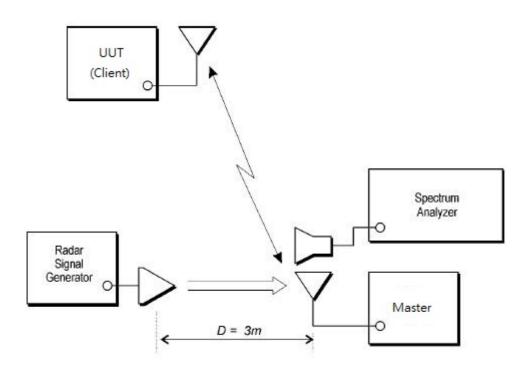

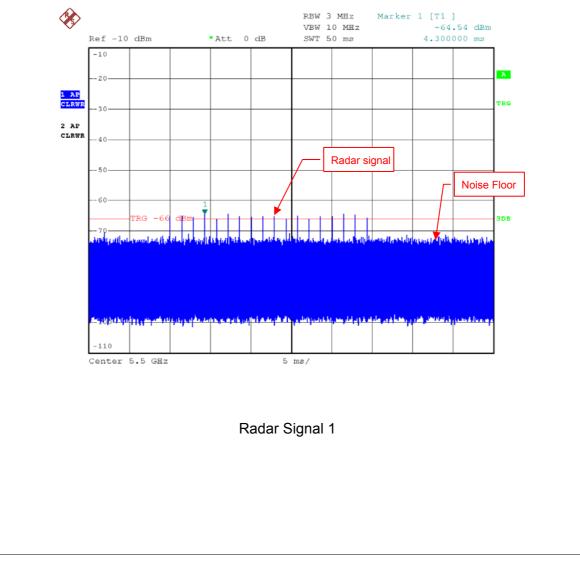

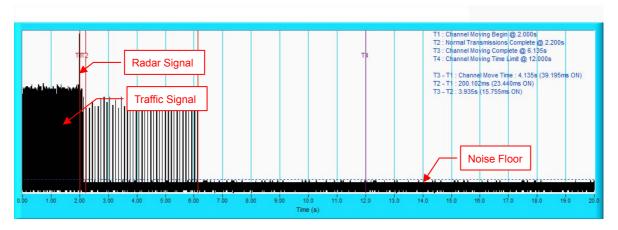
For a detection threshold level of -64dBm, the required signal strength at EUT antenna location is -64 dBm. The tested level is lower than required level hence it provides margin to the limit.



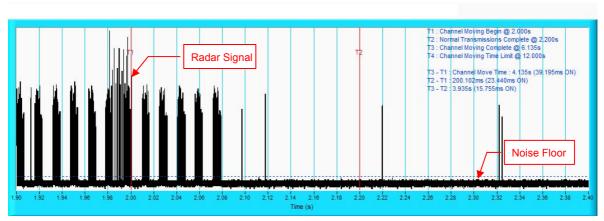

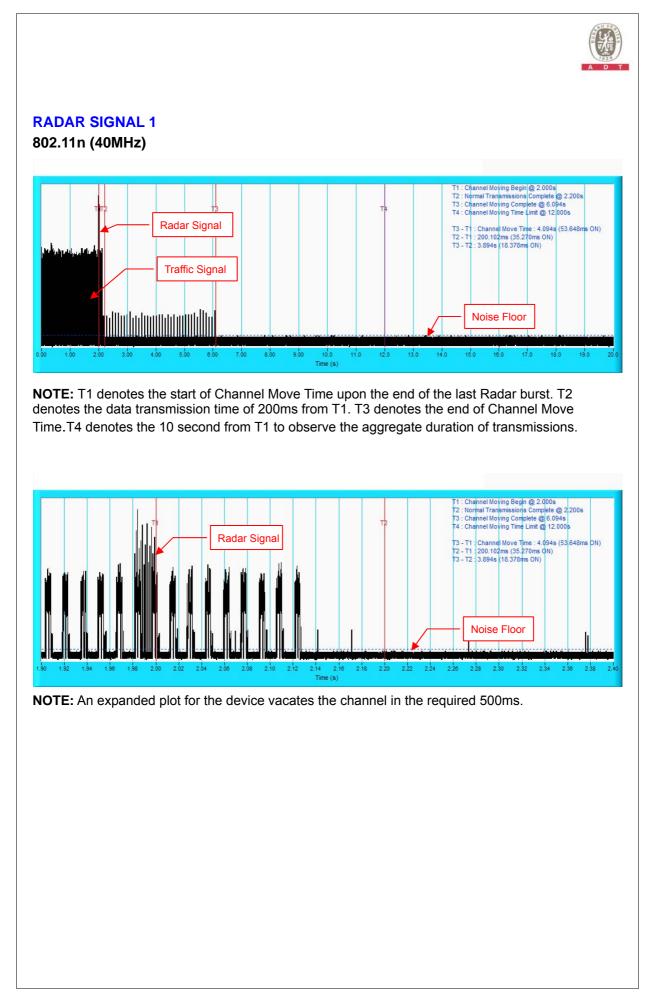
### RADAR SIGNAL 1 802.11n (20MHz)

NOTE: An expanded plot for the device vacates the channel in the required 500ms.



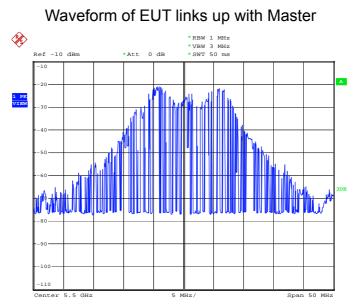

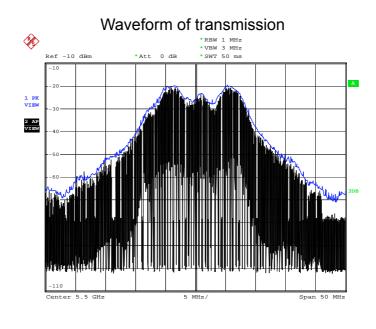

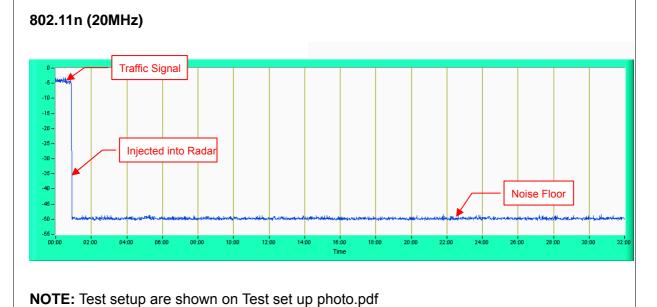

Plot of 30minutes period

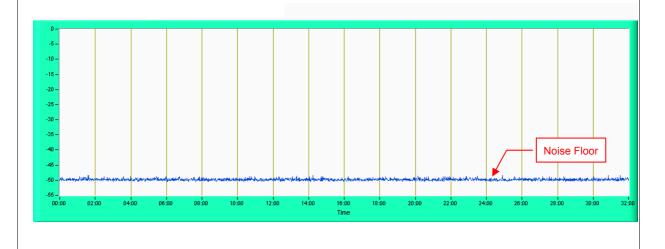




## 6.2.4 NON-ASSOCIATED TEST
