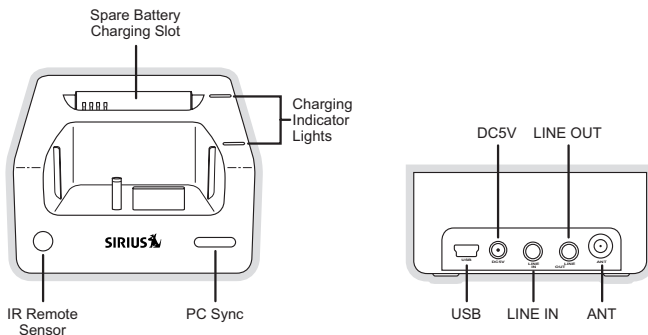

REMOTE CONTROL BATTERY INSTALLATION

To install the remote control battery, locate the battery drawer on the bottom edge. Open the battery drawer by holding the latch tab to the right and sliding the drawer out as shown in Figure 3. Place the battery in drawer with the + side of the battery facing up and slide the drawer back into the remote control.

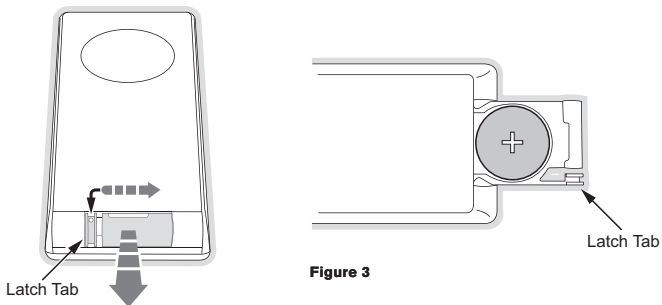

Installation

Installing the Home Dock

When installing the home dock in your home, choose a location in close proximity to your home entertainment system, PC computer, or amplified speakers, and also where the cable from the indoor/outdoor antenna can reach the home dock. The location should be easily accessible and provide good visibility of the display, and should not be located where it will be in direct sunlight which will affect the visibility of the display screen.

Connecting the AC Power Adapter

Connect the AC Power Adapter to the **DC5V** connector at the rear of the home dock (Figure 4), and plug it into a wall outlet.

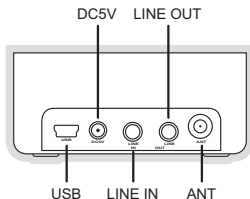

Docking the SIRIUS Radio

Place the SIRIUS radio into the home dock, aligning the connector on the radio with the connector on the home dock, and gently press the radio down until it is fully seated in the home dock. (Figure 5)

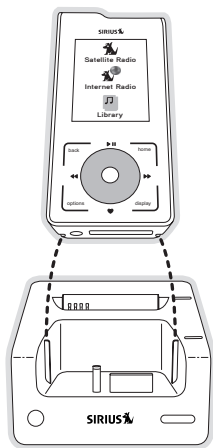

Installing the Indoor/Outdoor Antenna

Before installing the indoor/outdoor antenna, read this entire section.

To ensure consistent reception of the SIRIUS signal in your home, it is important that the antenna be oriented correctly. Note the following considerations for antenna placement:

BEST reception can be achieved by placing the antenna outside on the roof, with a clear 360 degree view of the sky. This position will afford the best view of the sky for best reception. When placed in this location, an antenna extension cable may be required.

BETTER reception can be achieved by placing the antenna outside a window, or by mounting it to the side of the house. In either case, try to achieve the best possible clear view of the sky.

GOOD reception can be achieved by placing your antenna in a window. Try to achieve a clear unobstructed view of the sky. If your location is in major metropolitan area, the antenna may be located inside the home because terrestrial transmitters are used to boost signal strength.

If you cannot obtain a clear 360 degree view of the sky (**Best**), then for the **Better** and **Good** installations you must at least have a clear view of the sky in the direction of the SIRIUS satellites, as shown in the following map diagram. (Figure 6)

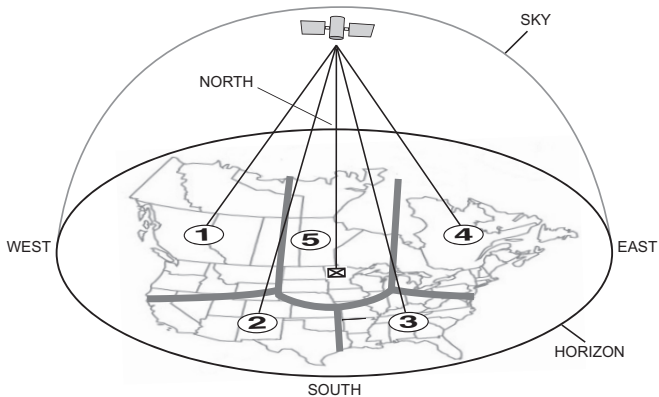

Use the map to find the area you are located in (1 to 5). Then find the direction in which you need to have a clear view of the sky:

- Area 1:** You will need a location with a clear view of the sky facing **EAST** or **NORTHEAST** or **SOUTHEAST**
- Area 2:** You will need a location with a clear view of the sky facing **NORTH** or **NORTH-EAST**
- Area 3:** You will need a location with a clear view of the sky facing **NORTH** or **NORTH-WEST**
- Area 4:** You will need a location with a clear view of the sky facing **WEST** or **NORTHWEST** or **SOUTHWEST**
- Area 5:** You will need a clear view of the sky facing **STRAIGHT UP** (Outdoors only)

Choose a mounting location for the antenna which has an unobstructed view of the sky in the direction for your area.

For example, suppose you live in **Area 2**. You determined that your antenna will need to have

a clear view of the sky facing **North** or **Northeast**. The exact direction is determined by your specific location in **Area 2** relative to the **X** on the map: If you live in **Texas**, you will need a more **North** facing clear view of the sky whereas if you live in **southern California**, you will need a more **Northeast** facing clear view of the sky.

Once you have found a suitable location for the antenna, route the antenna cable to the home dock. Be sure you avoid any obstructions that could crimp, kink, or twist the cable. Use protective grommets wherever rough openings are encountered. If the antenna is installed outdoors, route the cable from the antenna location to the interior of the home, working the cable through the basement, under a window sill, etc., and make adjustments to take up cable slack as necessary. Connect the antenna cable to the **ANT** connection on the rear of the home dock. (Refer to Figure 4 on page 16.) Optional antenna extension cables are available if needed. Refer to the **Optional Accessories** section for more details.

Testing and Optimizing the Antenna Signal Strength

The stronger the SIRIUS signal strength, the less likely it is that you will experience an interruption of the audio when listening to a broadcast. To assist you in adjusting the antenna aiming for optimal reception, your SIRIUS radio can display a screen showing the strength of the SIRIUS signal being received. (Figure 7)

To access the antenna aiming or signal indicator screen, consult the manual which accompanies your SIRIUS radio. The SATELLITE portion of the display screen (Figure 4) shows the strength of the signal being received from the satellite, while the TERRESTRIAL portion of the display screen shows the strength of the signal being received from terrestrial based transmitters, if available. Make small adjustments to the aiming of the antenna until you achieve the strongest possible signal.

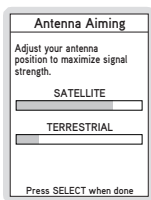

Connecting the Stiletto Home Dock to an Audio System

There are two primary ways to connect your SIRIUS satellite radio to your home entertainment system: direct connect or wireless. The following sections will help you obtain the best performance.

DIRECT CONNECTION

A direct connection provides better audio performance than a wireless connection and removes the possibility of interference from local FM broadcasters. There are several ways to directly connect your Stiletto which are explained in the following sections.

Direct Connect to your Home Entertainment System

The Stiletto can be connected to your home entertainment system using the AUX IN or LINE IN connection of your home entertainment system. (Figure 8)

1. Connect the provided audio cable which has the 1/8" (3.5mm) connector on one end, and the two RCA-type connectors on the other end to the **LINE OUT** connection at the rear of the home dock. (Refer to Figure 4 on page 16.)
2. Connect the L/R RCA-type connectors to the **AUX IN** or **LINE IN** connection on your home entertainment system.

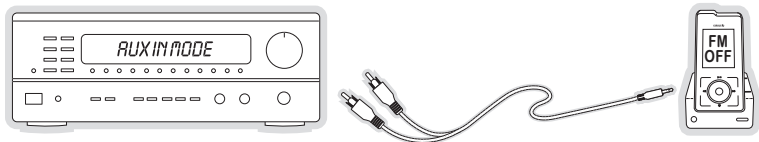

Note: Refer to your manufacturer's guidelines for correct installation to your home entertainment system.

Direct Connect to Amplified Speakers

Amplified speakers can be connected to the home dock. (Figure 9) The speakers must have a 1/8" (3.5mm) connector to connect to the home dock.

1. Connect the cable from the speakers to the **LINE OUT** connection at the rear of the home dock. (Refer to Figure 4 on page 16.)

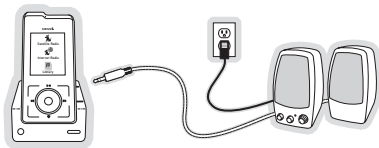

Integrate the Home Dock With Your PC computer

You can integrate the home dock with your PC computer's sound system so that you can utilize a single set of amplified speakers for listening to both the PC computer and the Stiletto. Using this connection method, you will be able to listen to Stiletto and use the PC computer at the same time. (Figure 10)

To connect your PC computer and the home dock to your PC computer's speakers, connect the audio cables as follows:

1. Make a note of the connector on your PC computer to which your speakers are connected. This is typically a green connector, and may be marked "Speakers" or have a speaker icon. Disconnect the wire plugged into that connector and plug that wire into the **LINE OUT** connection on the rear of the home dock. (Refer to Figure 4 on page 16.)
2. Connect the provided audio cable which has the 1/8" (3.5mm) connectors on both ends into the connector on the PC computer which had been connected to the speakers.
3. Connect the other end of this cable to the **LINE IN** connection at the rear of the home dock. (Refer to Figure 4 on page 16.)
4. Plug the AC adapter of the speakers into an AC outlet, and connect it to the speakers.

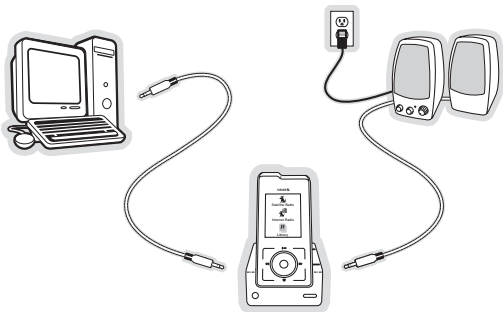

WIRELESS CONNECTION

Your SIRIUS radio contains an FM transmitter. The FM transmitter sends the audio from your SIRIUS radio to your home entertainment system. (Figure 11)

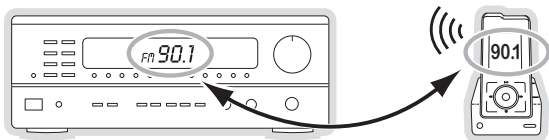

To tune your transmitter:

1. Turn off your SIRIUS radio and tune through the FM channels on your home entertainment system to locate an FM channel that is not broadcasting in your area. If you

use an FM channel that is being used by a local broadcaster, it will interfere with the performance of your SIRIUS radio. Once you have located an FM channel that is not broadcasting in your area, save it as a preset on your home entertainment system. This will become your SIRIUS preset.

2. Turn on your SIRIUS radio. Press the **FM** button on the remote control. Use the **◀** and **▶** buttons to change the FM channel to match the SIRIUS preset on your home entertainment system.

Note: The FM transmitter in your SIRIUS radio is automatically set to FM channel 88.1. This may not be the best channel in your area.

If you're not sure which FM channels are not broadcasting in your area, you can also go to <http://sirius.com/fmchannel> and search for a suggested FM channel based on your zip code.

My Sirius Studio Software Installation

If you are using the home dock to connect to your PC computer, the My Sirius Studio[®] software included with your Stiletto will allow you to connect your Stiletto to your PC. The software requires your PC computer to be using the Microsoft Windows[®] XP operating system with Service Pack 2 installed.

Important: The software must be installed *before* connecting the Stiletto to your PC computer.

The following list provides a few highlights of the capabilities of the software:

- Create playlists and download songs to the playlists.
- Streaming of SIRIUS music channels over the internet.
- Check for updates to the operating system software and download them to Stiletto, and re-install deleted operating system files.

During installation you will be given the opportunity to install Yahoo! Music Engine™ software. The Yahoo! Music Engine software will recognize the Stiletto and enable you to manage playlists and download music files. Yahoo! Music Engine will also allow you to view the songs and artist saved by you as "Favorites". By using the Yahoo! Music Engine software, it may be possible to purchase or download this content.

To install the My Sirius Studio software:

1. Place the My Sirius Studio software CD into your PC computer's CD-ROM drive to start the software installation.

2. If the installation does not begin automatically, double click the *SiriusStudioSetup* icon to begin the installation.
3. Follow the prompts of the software to complete the installation.

When the PC computer has rebooted, the My Sirius Studio software will be ready to use. Please refer to the user manual included on the software CD for instructions on using the software.

Connecting the USB Cable

If you will be using your PC computer with the home dock, connect the provided USB cable to the **USB** connection on the rear of the home dock. (Refer to Figure 4 on page 16.) Connect the other end of the USB cable to an available USB port on your PC computer. (Figure 12)

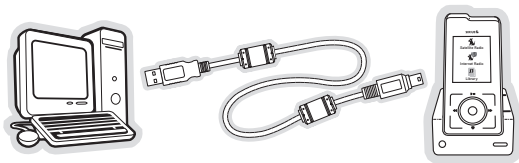

Subscribing to the SIRIUS Service

Before you can listen to the SIRIUS service, you need to activate your subscription. To subscribe, do the following:

1. To activate your Stiletto, first be sure the battery is fully charged. Attach the antenna headphones and position yourself so that your Stiletto is receiving a good SIRIUS signal, as described in the previous section.
2. Select *Satellite Radio* → *All Channels* and tune to channel 184. The SIRIUS channel line-up will begin updating. Wait until the channel updates have completed before pressing any buttons.
3. Once the channels have been updated, the display will change to *Call 1-888-539-SIRIUS to Subscribe*. You should be able to hear audio from channel 184, the SIRIUS Weather and Emergency channel.
4. Use the **Media Dial** to tune to channel 0 to display the Stiletto's unique 12-digit SIRIUS ID Number (SID). (Figure 13) The SID number is also available on the Stiletto's packaging, and may also be accessed by selecting *Settings* → *Device* → *Sirius ID*.

Write the SID number down in the space provided near the end of this user guide.

5. Have your credit card handy and contact SIRIUS on the Internet at:

and follow the prompts to activate your subscription. You can also call SIRIUS toll-free at: 1-888-539-SIRIUS (1-888-539-7474).

6. When you have successfully subscribed to the SIRIUS service, and the Stiletto has been updated with your subscription information, an alert will be displayed. To continue, press the ● Select button.

You are now ready to begin enjoying Sirius Satellite Radio's digital entertainment, and can tune to other channels!

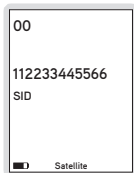

Operation

Battery Charging

When the Stiletto is placed in the home dock, or a spare battery is placed in the charging slot, the battery charging indicator lights (Figure 14) will display the following charging information:

Indicator Light	Description
Slow Blinking	Battery is charging
Steady	Charge complete

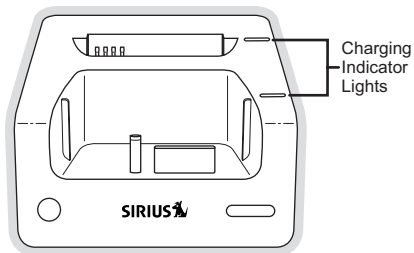

The home dock can also charge a spare battery. Align the contacts on the bottom inside of the battery with the contacts in the charging slot. (Figure 15) When correctly inserted, the charging indicator light will display the charging status as described previously.

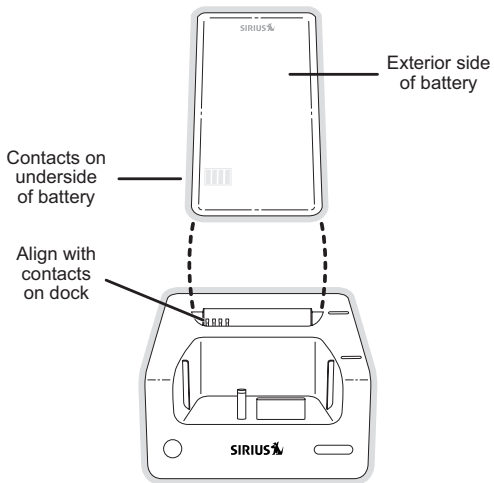

Scheduling a Recording

To schedule a recording, select *Setup New Recording* from the Recording menu. (Figure 16) The *New Recording* screen allows you to set the parameters of the recording. (Figure 17) Use the **Media Dial** to highlight a parameter and press the **Select** button. Then use the **Media Dial** to scroll the list until the correct selection is highlighted, and press the **Select** button to select it. When complete, select *Done*.

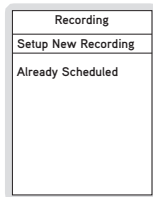

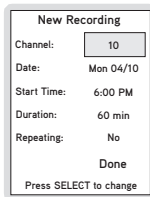

The following table describes each parameter of the scheduled recording.

Parameter	Description	Notes
Channel	Any SIRIUS broadcast channel may be selected	If a channel which has been locked with the parental control feature is selected, the password must be entered before you can listen to the recording
Date	The date of the recording	Dates may be selected from the present date to 4 weeks in the future
Start Time	The time of day the recording will begin	If the date and time chosen has already passed, you will receive a warning when you attempt to save the scheduled recording
Duration	The amount of time to record	Recording times of 5 minutes to 6 hours may be selected

Parameter	Description	Notes

If there is not enough memory to complete a scheduled recording, a *Not Enough Space* error message will be displayed when you select *Done* to complete your recording setup. You'll need to delete files from your library to free up space before you can save the scheduled recording. If the memory is full when a scheduled recording is set to begin, an error message will be displayed and the recording will not occur.

Note: Scheduled recordings on multiple channels cannot happen at the same time. If an attempt is made to create a scheduled recording which will conflict with an existing one, the *Recording Conflict* error message will be displayed and give you the option to either cancel the older conflicting recording or change the settings of the new recording.

Synchronizing the Stiletto to your PC computer

To synchronize the Stiletto to your PC computer, be sure the USB cable is connected between the home dock and your PC computer, and that you have installed the My Sirius Studio software.

Place the Stiletto in the home dock and press the PC SYNC button to initiate the USB connection. If you attempt to use the Stiletto while the USB connection is active, you will be prompted to confirm that you wish to disconnect from the PC computer, and terminate the USB connection.

Refer to the software manual included on the My Sirius Studio CD-ROM for more information about using the software, or the manual may be downloaded from the SIRIUS website at <http://www.sirius.com>.

Troubleshooting

Symptom	Solution
SIRIUS radio does not power on	Check the battery to be sure it is installed correctly. Charge the battery. Check that the radio is properly seated in the home dock. Check the AC power adapter to be sure it's plugged into a working AC outlet, and connected to the home dock.
SIRIUS radio displays: <i>Antenna Not Detected</i>	The windowsill antenna is not connected to the home dock. Check the antenna connection to the home dock.
SIRIUS radio displays: <i>Acquiring Signal</i>	The Stiletto is searching for a satellite signal. Check for obstacles over or around the satellite antenna. Change your location to eliminate nearby obstacles such as buildings, overhangs, bridges, overpasses, etc.
Audio from broadcasts starts and stops	The windowsill antenna is not aimed for optimal reception. Refer to the section <i>Installing the Indoor/Outdoor Antenna</i> and follow the instructions for aiming the antenna.
No sound	The home dock is not connected or is incorrectly connected to the PC computer sound system, amplified speakers, or home entertainment system. Refer to the section <i>Connecting the Stiletto Home Dock to an Audio System</i> and follow the instructions carefully.

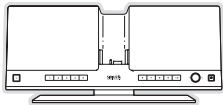
