Cover Letter for re-use of Test Data

To Whom It May Concern:

The initial application has been granted according to 47CFR Part 15.247 & 15.407 and Part 22/24/27 for FCC ID: **NKS-PA1**.

The new equipment to be Granted in this new application, according to FCC ID: **NKS-MA1BA1TE1**, only differs from the initial version (FCC ID: **NKS-PA1**) with the only 1 following point:

1. All have the same PCB layout and supported bands as Trimble Gateway-PA1 (FCC ID: NKS-PA1), only difference is this FCC ID has the reserved 802.11ah circuit depopulated.

The described above do not affect the radio characteristics (BT & 802.11a/b/g/n & WWAN) of the equipment. Consequently, radio test data retrieved from the initial application FCC ID: NKS- PA1 can be re-used for the FCC ID: NKS-MA1BA1TE1 equipment.

However, Based on our knowledge and our engineering judgment of the device design, the changes made, the format and amount of spot-check test data are decided as below,

1. Sample amount: 3
2. Spot-check rule part, frequency band and test items as described in each test report
3. Spot-check measurement result refer to the test report of FCC ID: **NKS-MA1BA1TE1** equipment.
