### 2 Test Configuration of Equipment Under Test

The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conducted emission (150 kHz to 30 MHz) and radiated emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Y plane) were recorded in this report.

The final configuration from all the combinations and the worst-case data rates were investigated by measuring the maximum power across all the data rates and modulation modes under section 2.2.

Based on the worst configuration found above, the RF power setting is set individually to meet FCC compliance limit for the final conducted and radiated tests shown in section 2.3.





### 2.6 EUT Operation Test Setup

The programmed RF utility "HTC SSD Test Tool", is installed in EUT to provide channel selection, power level, data rate and the application type. RF Utility can send transmitting signal for all testing. The RF output power selection is for the setting of RF output power expected by the customer and is going to be fixed on the firmware of the final end product.

### 2.7 Measurement Results Explanation Example

#### For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

### Example:

The spectrum analyzer offset is derived from RF cable loss and attenuator factor.

Offset = RF cable loss + attenuator factor.

Following shows an offset computation example with cable loss 4.2 dB and 10dB attenuator.

- 3. The EUT was set 3 meters from the interference receiving antenna which was mounted on the top of a variable height antenna tower.
- 4. The antenna is a broadband antenna and its height is adjusted between one meter and four meters above ground to find the maximum value of the field strength for both horizontal polarization and vertical polarization of the antenna.
- 5. For each suspected emission, the EUT was arranged to its worst case and then adjust the antenna tower (from 1 m to 4 m) and turntable (from 0 degree to 360 degrees) to find the maximum reading.
- 6. For testing below 1GHz, if the emission level of the EUT in peak mode was 3 dB lower than the limit specified, then peak values of EUT will be reported, otherwise, the emissions will be repeated one by one using the CISPR quasi-peak method and reported.
- 7. For testing above 1GHz, the emission level of the EUT in peak mode was 20dB lower than average limit (that means the emission level in average mode also complies with the limit in average mode), then peak values of EUT will be reported, otherwise, the emissions will be measured in average mode again and reported.

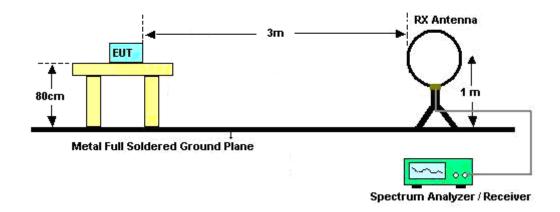



#### For radiated emissions from 30MHz to 1GHz


