




(A) Radiated Emission Test Set-Up, Frequency Below 30MHz.

12.3 Measurement Procedure

- The EUT was placed on a turn table which is 0.8m above ground plane.
- The testing follows FCC KDB 789033 D02 General UNII Test Procedures New Rules.
- The EUT was placed on a turn table with 0.8m for frequency< 1GHz and 1.5m for frequency> 1GHz above ground plane.
- The turn table shall rotate 360 degrees to determine the position of maximum emission level.
- EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
- Set the spectrum analyzer as RBW=100 kHz and VBW=300 kHz for Peak Detector (PK) at frequency between 30MHz and 1 GHz.
- Use receiver mode as RBW=120 kHz for Quasi-peak (QP) at frequency between 30MHz and 1 GHz.
- At frequency above 1 GHz, Set the spectrum analyzer:
 - A. RBW=1 MHz, VBW=3 MHz for Peak Detector.
 - **B.** Set the spectrum analyzer as RBW=1 MHz, VBW=10 Hz (Duty cycle > 98%) or VBW ≥ 1/T (Duty cycle < 98%) for **Average** Detector.
- Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- **10.** And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- **11.** Repeat above procedures until all frequency measured were complete.

The field strength is calculated by adding the Antenna Factor and Cable Factor and subtracting the Amplifier Gain and Duty Cycle Correction Factor (if any) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CL - AG

Where FS = Field Strength

CL = Cable Attenuation Factor (Cable Loss)

RA = Reading Amplitude

AG = Amplifier Gain

AF = Antenna Factor
