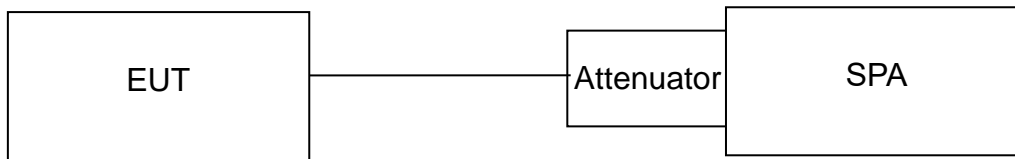

11.2 Measurement Procedure

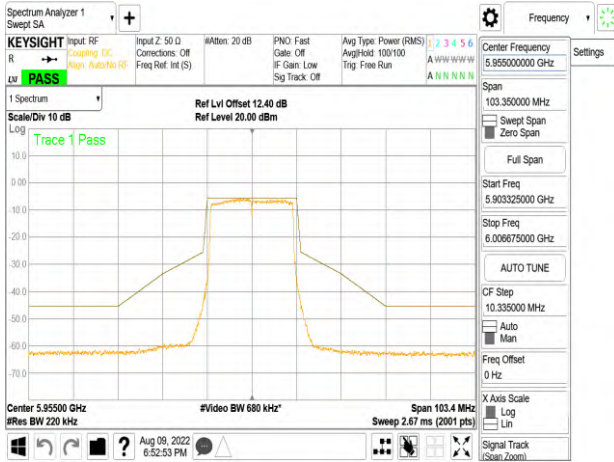
1. Place the EUT on the table and set it in transmitting mode.
2. The testing follows FCC KDB 987594 D02 In-Band Emissions procedure:
 - a. Set the span to encompass the entire 26 dB EBW of the signal
 - b. Set RBW = same RBW used for 26 dB EBW measurement
 - c. Set VBW $\geq 3 \times$ RBW
 - d. Number of points in sweep $\geq [2 \times \text{span} / \text{RBW}]$.
 - e. Sweep time = auto.
 - f. Detector = RMS
 - g. Trace average at least 100 traces in power averaging (rms) mode
 - h. Use the peak search function on the instrument to find the peak of the spectrum.
3. For the purposes of developing the emission mask, the channel bandwidth is defined as the 26 dB EBW.
